COURT WHEN THE PARISH DISTRICT ATTORNEY'S OFFICE SAID IT DID NOT NEED GARRISON TODAY. THE ARTICLE REPORTED THAT THE FOLLOWING INDIVIDUALS WERE SUBPOENAED TO APPEAR BEFORE THE TERREBONNE PARISH GRAND JURY:

TED COBB, FIELD SERVICE MANAGER FOR SCHLUMBERGER AT MORGAN CITY; WILLIAM GURVICH, WHO AT ONE TIME WAS GARRISON'S CHIEF INVESTIGATIVE AIDE IN THE PROBE; RANCIER B. EHLINGER, A FORMER BUSINESS ASSOCIATE OF GORDON NOVEL; MARLENE MANCUSO, EX-WIFE OF GORDON NOVEL; AND PATROLMAN LEROY BELANGER OF THE HOUMA PD WHO INVESTIGATED THE THEFT COMPLAINT.

THE ARTICLE REPORTED THAT THE NEW ORLEANS GRAND JURY CALLED TWO WITNESSES IN CONNECTION WITH GARRISON'S PROBE AND IDENTIFIED THESE WITNESSES AS MRS. JOSEPHINE HUGG, A FORMER SECRETARY FOR THE INTERNATIONAL TRADE MART DURING CLAY SHAW'S TENURE AS MANAGING DIRECTOR, AND MIGUEL TORRES WHO WAS BROUGHT FROM THE ANGOLA STATE PENITENTIARY TO NEW ORLEANS UNDER A WRIT OF HABEAS CORPUS.
