IRICK advised he presently resides at 1906 Ganyard Drive, Houston, Texas, telephone number HO 8-3450 and he has been residing in Houston since the latter part of February 1967, when he moved to Houston from Dallas, Texas. He stated he moved in to the above residence on 3/1/67.

IRICK advised that prior to coming to Houston his address in Dallas was 3017 Topaz, which is located in the Farmers Branch area of Dallas. IRICK stated he had resided in Dallas since 7/1/64 and prior to that time was residing in Austin, Texas. IRICK advised that at the time of the assassination of President KENNEDY he was residing in Austin, Texas. IRICK stated his wife found the address book in the webbing underneath the sofa at their residence while cleaning the sofa. He stated his wife previously cleaned the interior of the couch approximately one year ago when they were residing in Dallas, Texas, and this address book was not located at that time. IRICK stated based on this he believes the address book must have become lodged in the bottom of the sofa within the past year. IRICK stated he has no idea as to who could possibly have placed the address book in the sofa or how it could have become lodged in the bottom of his sofa. He stated the sofa has been in their possession during the past year with the exception of approximately one week when the furniture was in storage in connection with his move from Dallas to Houston, Texas. IRICK stated he is not personally acquainted nor does he have any knowledge of any persons whose names he has read in the paper as being connected with the KENNEDY assassination or the GARRISON assassination probe in New Orleans.
