

## SHAW HEARING TO BE MONDAY

### Defense Seeks to Quash Conspiracy Indictment

A criminal district court hearing, expected to be the last before the conspiracy trial of retired New Orleans businessman Clay L. Shaw, was set for 10 a. m. Monday by Judge Edward A. Haggerty Jr.

Judge Haggerty set the hearing Wednesday for a defense motion to quash Shaw's conspiracy indictment and said he will rule on the matter by Sept. 18.

F. Irving Dymond, one of Shaw's attorneys, subpoenaed 33 witnesses for the hearing, including members of the grand jury which indicted Shaw; members of the district attorney's office; members of Truth and Consequences of New Orleans Inc.; and criminal district court judges.

Shaw was arrested on March 1, subsequently ordered held over for trial at a preliminary hearing, and later indicted by the outgoing grand jury for allegedly conspiring to murder President John F. Kennedy.

Shaw's defense filed a supplemental motion to quash his indictment on Sept. 1, after earlier filing the original motion to quash.

### STATE'S ANSWER

Wednesday, Assistant District Attorney James L. Alcock filed the state's answer to the supplemental defense motion.

Judge Haggerty said that representatives of local news media will be seated at a press table during the trial. Out-of-town newsmen will be seated in the spectators' area. Deputies of Criminal Section

Louis A. Heyd Jr. will search all persons entering the court room, and no cameras or recording devices will be permitted inside the courthouse.
