INFORMATION CONCERNING

On 10/3/67 an individual who identified himself as Dr. JOHN EDWARD MC INTOSH telephonically contacted the Asheville, N. C., RA and advised he was Dr. JOHN EDWARD MC INTOSH and was presently confined to the Highland Hospital, Asheville, N. C. He furnished the following information:

Dr. MC INTOSH stated he had recently been employed by the Abbott Pharmaceutical Corp. in Chicago, Ill, when he became addicted to drugs and was required to give up this employment as a result of his being arrested for drug addiction. He stated he checked into Highland Hospital, Asheville, N. C., for treatment and would be at this institution for the next 3-5 months.

Dr. MC INTOSH could not give any specific information but stated he was a friend of JIM GARRISON, who was identified as the County Prosecutor, New Orleans, La. He also stated that CLAY SHAW, New Orleans, La.; was a personal friend of his. Dr. MC INTOSH stated he was a "switch hitter", meaning he was a homosexual. Dr. MC INTOSH stated he had a girl friend, _____ Memphis, Tenn., and that she is employed at the University of Tenn., Medical Center, Memphis, Tenn., as an _____ and works for a Dr. _____ of that institution. He stated that _____ is a personal friend of one _____ who is employed at the _____ New Orleans, La., and in turn _____ is _____
