Enclosed for Dallas and Atlanta are two Xerox copies of a letter from Mr. Fred M. Vinson, Jr., Assistant Attorney General, and two Xerox copies of a letter from Mr. Terry Christie addressed to the Attorney General which are self-explanatory.

Attention is directed to paragraph two of Mr. Christie's letter, and in this respect, Dallas should search indices of the Dallas Office in an effort to identify the former neighbor of Jack L. Ruby. If this individual is identified and was previously interviewed, identify the report and pages in which the interview was revealed-so that it may be reviewed at the Bureau.

Copies have been furnished to the Atlanta Division for information in the event it is necessary to interview Mr. Christic to establish the identity of the professor currently with Southern Methodist University who was alleged to have received information from his friends who lived next door to Ruby that on the night before the assassination, Lee Harvey Oswald came to the door asking for Ruby's residence.

It is noted that according to Mr. Christie's letter this information has previously been furnished to Jim Garrison in New Orleans in connection with his investigation of the assassination, and in connection with this matter, no interviews are to be conducted without prior Bureau approval.

Based on information furnished, Terry Christie was not identified in Bureau files; however, he may be iden-tical with one Trevor Lauman Christie, born March 3, 1905, San Francisco, California, who was investigated in 1951 by request of the State Department, Public Law 402, 80th Congress, Voice of America. This investigation revealed no derogatory information. Atlanta through available sources establish the identity of Terry Christie, and advise the Bureau and Dallas.

All leads are to be handled immediately so that Nr. Christie's communication can be acknowledged as requested by the Department.

We received a letter from the Department enclosing a copy of letter addressed to the Attorney General bearing the signature Terry Christie, instructor in history and political science, Dalton Junior College, Dalton, Georgia. Christie advised that a professor currently with Southern Methodist University, Dallas, who was not identified, had visited friends in Dallas who had lived next door to Jack Ruby. He was apparently informed by these friends that on the evening preceding the assassination, November 21, 1963; that Lee Harvey Oswald was alleged to have come to their door looking for the residence of Jack Ruby. It was alleged this information was furnished to Jim Garrison of New Orleans, and it is known that in connection with his conspiracy investigation, he is attempting to establish an association betweed Oswald and Ruby. Our investigation did not conclude there was ever any association between Oswald and Ruby. Dallas is being advised to search files to determine if the alleged neighbor. of Ruby's can be identified and whether they were interviewed previously regarding this matter prior to the time any additional interviews are conducted.
