AS A WITNESS BEFORE THE ORLEANS PARISH GRAND JURY IN CONNECTION
WITH DA JIM GARRISON'S ASSASSINATION PROSE. DALZELL
WAS QUOTED AS SAYING THAT THE REASON FOR HIS BEING CALLED
AS A WITNESS CONCERNS THE KENNEDY ASSASSINATION, THE BACK-
GROUND OF IT. DALZELL DESCRIBED HIMSELF AS AN EARLY FOE
OF FIDEL CASTRO AND SAID HE HAD FOUNDED A SHORT WAVE RADIO
PROGRAM KNOWN AS FREE VOICE OF LATIN AMERICA AND A GROUP
