THE DALLAS TIMES HERALD ON NOV. TWO LAST, ON PAGE A27, CARRIED
ARTICLE CAPTIONED "GARRISON PROBE FIGUPE CLAIMS SHOT." THIS ARTICLE
STATED ROGER CRAIG, FORMER DALLAS COUNTY DEPUTY SHERIFF WHO RESIGNED
FROM DALLAS COUNTY SO LAST JULY, AFTER EIGHT YEARS TO BECOME A
PRIVATE INVESTIGATOR FOR A BAIL BONDSMAN, HAD STATED SOMEONE SHOT AT
HIM WEDNESDAY MORNING NOV. ONE LAST IN A PARKING LOT AT CARROLL AND
COLUMBIA STREETS IN EAST DALLAS.

ARTICLE CONTIPUED THAT CRAIG SAID HE BELIEVED HIS GOING TO NEW
ORLEANS LAST WEEK FOR INTERROGATION BY DA JIM GARRISON WAS PROBABLY
CONNECTED WITH THE ATTEMPT ON HIS LIFE. ARTICLE STATED CRAIG HAD
INDICATED HE WAS "TAILED" WHILE IN NEW ORLEANS ON LAST WEDNESDAY AND
THURSDAY, OCT TWENTYFIVE AND TWENTYSIX, LAST, AND IS STILL BEING
"TAILED" IN DALLAS.

THE ARTICLE SUMMARIZED INFORMATION FURNISHED BY CRAIG DURING THE ASSASSINATION INVESTIGATION WITH RESPECT TO HIS HAVING IDENTIFIED INDIVIDUAL LEAVING TSED AND ENTERING VEHICLE AS LEE HARVEY OSWALD. ARTICLE STATED CRAIG HAD NOT REPORTED SHOOTING TO DALLAS POLICE BECAUSE HE WAS NOT SURE GARRISON WANTED HIM TO.

REPORT OF SA ROBERT P. GEMBERLING DATED NOV. THIRTY, SIXTY THREE, CAPTIONED "LEE HARVEY OSWALD, AXA., IS -R -CUBA" ON PAGE 42 REFLECTS INTERVIEW OF SHERIFF BILL DECKER, DALLAS, ON DEC. NINE, SIXTYTHREE, AS TO HIS EVALUATION OF CRAIG'S PREVIOUS REMARKS INDICATED IN INTERVIEWS DESCRIBED ABOVE.

REPORT OF SA ROBERT P. GEMBERLING DATED APRIL FIFTEEN, SIXTYFOUR, IN LEE HARVEY OSWALD CAPTION CASE, REFLECTS INTERVIEW OF CRAIG ON MAR. THIRTYONE, SIXTYFOUR WHICH INTERVIEW DOES NOT RELATE TO INCIDENT ABOUT INDIVIDUAL BELIEVED TO BE OSWALD ENTERING VEHICLE.
