 SO, LINNEUS, MO., ADVISED ON NOVEMBER THIRTEEN LAST, THAT  
 RAYMOND WALTERS, AN AWOL SOLDIER (FORMERLY A SELECTIVE SERVICE  
 VIOLATION, ST. LOUIS ORIGIN), WAS ARRESTED BROOKFIELD, MO,  
 NOVEMBER ONE LAST ON OLD BAD CHECK CHARGE AND AWOL. SENTENCED  
 TO NINETY DAYS OR FIVE HUNDRED EIGHTEEN DOLLARS AND FIFTY CENTS  
 FINE. IN JAIL DEFAULT OF BOND WITH PERMISSION OF JUDGE TO MAKE  
 TELEPHONE CALLS IN ORDER TO OBTAIN FINE. SEVERAL CALLS MADE,  
 APPARENTLY ONE TO DISTRICT ATTORNEY GARRISON'S OFFICE IN  
 LOUISIANA. ON NOVEMBER THREE LAST ASSISTANT DISTRICT ATTORNEY  
 JIM ADCOCK CALLED WALTERS AT THE JAIL, MADE REFERENCE TO  
 PRIOR CALL. ON NOVEMBER THIRTEEN LAST, AT ONE FORTYFIVE PM,

ADCOCK CALLED AGAIN, ASKED IF WALTERS COULD TALK AND WALTERS SAID "NO, BUT YOU CAN." ADCOCK STATED HE NEEDED A CERTAIN PHOTOGRAPH BEFORE OCTOBER FOURTEEN SIXTYEIGHT, "THE DAY THE LID WILL BLOW OFF." WALTERS SAID A MINISTER FRIEND IN DALLAS HAS THE PHOTOGRAPH. HE MENTIONED HE WAS IN DALLAS IN JULY OR AUGUST SIXTYSEVEN WITH THIS P<sup>C</sup>REACHER AND SAW THE PHOTOGRAPH. WALTERS SAID RUBY AND OSWALD WERE <sup>A</sup>IN CUBA TWO MONTHS PRIOR TO THE KENNEDY ASSASSINATION. ADCOCK ASKED HOW THEY GOT INTO CUBA. WALTERS SAID "I DON'T KNOW. CAN'T TALK BUT COULD TELL YOU MORE IF I SAW YOU." ADCOCK WANTED TO KNOW WHY THEY WERE IN CUBA AND WALTERS SAID "AN OIL DEAL." WALTERS REFERRED TO FACT THAT OSWALD AND RUBY WERE SEEN HOLDING RIFLE AND THIS MAY BE THE PHOTOGRAPH REFERRED TO BY ADCOCK. WALTERS INDICATED HE WAS A FRIEND OF RUBY AND THEY WERE TOGETHER A MONTH PRIOR TO THE ASSASSINATION IN DALLAS AND THAT THEY AND OTHERS MET AT A LOUNGE OR EATING HOUSE NORTH OF DALLAS BUT HE WOULD NOT ELABORATE. WALTERS ALSO STATED THERE WAS AN EATING HOUSE USED BY THEM THIRTY MILES NORTH OF COLUMBUS. (WALTERS WORKED IN

COLUMBUS, OHIO, ABOUT NINETEEN SIXTYTHREE.) ADCOCK TOLD WALTERS HIS OFFICE COULD NOT COME TO LINNEUS TO PAY FINE AS IT WOULD BE UNETHICAL AND AS "THEY ARE ALREADY HOT ON OUR TAILS." ...COULDN'T AFFORD TO LET NEWS<sup>E</sup> GET OUT, INDICATED THEY WOULD PAY HANDSOMELY FOR WALTERS' TESTIMONY AND PAY HIS TRAVEL EXPENSES IF HE COULD COME DOWN THERE. HE SAID "HELL BOY WE'VE GOT TO HAVE YOU DOWN HERE BEFORE FEBRUARY FOURTEEN SIXTYEIGHT AND BEFORE YOU'RE TURNED OVER TO THE ARMY CAUSE IF THEY GET YOU WE WON'T." ASKED IF WALTERS COULD SLIP A LETTER OUT OF JAIL IN CODE ADDRESSED TO HIM AS JIM ADCOCK, TWO SEVEN ZERO ZERO LANE AVENUE, CITY NOT GIVEN.

WALTERS IS DESCRIBED AS CONNIVER; MAY OR MAY NOT HAVE INFORMATION OF VALUE TO GARRISON'S OFFICE AND MAY BE USING A TRUMPED UP STORY TO OBTAIN MONEY FROM THEM.
