This Sheriff's Office censors all mail and all phone calls received or transmitted by the prisoners as a matter of security except those involving the relationship between the prisoner and his attorney. ADCOCK in this case was not in this category and the mentioned conversation was monitored for its duration which was approximately 35 minutes.
