The Relationships of the Central Intelligence Agency

to Justice Department (The Investigation)

District Attorney Garrison Will Say Who Killed

Rose Cheronie

Jim Garrison, the District Attorney of New Orleans, conceded an exclusive interview to the "Playboy" review, before the trial of Clay Shaw, which should take place in the beginning of November.

In the mass of new data which emerged, that related to a member of the conspiracy who still is in contact with the neo-fascist party in Italy is emphasized.

Other data is related to documents falsified by the Central Intelligence Agency in order to mislead the investigation of the Warren Commission.

Finally, there also is data dealing with revelations of one of the rumored victims of the assassination, a certain Miss Rose Cheronie, who affirmed, on November 13, 1963, that she knew about a conspiracy against Kennedy. Now, Garrison has discovered that Rose Cheronie has been kidnapped.

The District Attorney Garrison has been submitted for months to the enormous pressure of the Government and of the press which are vainly attempting to induce him to abandon the investigation of the conspiracy against Kennedy.

Garrison has not yielded about matters which could in any way compromise the Constitutional rights of the main defendant, Clay Shaw.

However, the District Attorney has thrown enough light in his above-mentioned interview to open a new box of Pandora, especially concerning the role played by the Central Intelligence Agency. Namely, this Agency repeatedly attempted to block all the roads pertaining to the activities of L. H. Cowdell, and of Jack Ruby before November 22, 1963.

Example No. 1

The document CD-287 is a photograph furnished by the Central Intelligence Agency to the Warren Commission. It purports to show Cowdell, in company of another individual, entering the Cuban Embassy in Mexico City for the purpose of obtaining the Cuban visa.

Garrison insisted that this photograph was false. He said that he knew that the photograph was a fake because he now knew that the name of the individual was different. Thus, what was the aim of the Central Intelligence Agency? The Agency wanted to hide the identity of the individual who accompanied Oswald and was an agent of the CIA. In fact, the Central Intelligence Agency wanted to keep secret the work of Oswald for the CIA.

Example No. 2

The document CD-903 contains data concerning the U-2 which Cowdell knew.

This is a coded document which will not be published for 75 years. However, the mere title of the document uncovers new elements related to Oswald. Actually, heretofore, it was not known that Oswald knew data concerning the top secret U-2, that is data which even President Macmillan did not know, as he said.

This is not all. There were other documents mentioned by Garrison which will be also kept in the national archives for 75 years. These documents contradict the assertions of the Central Intelligence Agency that it did not know anything about Oswald's activities before November 22, 1963.

The State Department had given to the Warren Commission a coded message written in 1960. In this message, the Central Intelligence Agency reported about Oswald's activities in the Soviet Union.

Nonetheless, the superagency for espionage still pretends to have been in the dark about Oswald until the famous November 22, 1963.

Finally, there is the case of Miss ~~Karen~~ Chonanico. *I.C. 4-1*

Dallas, Texas

The girl in question was a little friend of Jack Ruby. She was found ~~gasping~~ at the edge of a highway near Mexico, Louisiana, on November 18, 1963.

She was quickly taken to a hospital where she told the physician in charge of the night service that she had learned that Kennedy had to be murdered "within a few days." That is why she was violently thrown out of the car which was going at a crazy speed.

Fortunately, she landed on a soft slope.

The physician paid little attention to the feeble explanations of Miss Chonanico. He took care of her health, and released her from the hospital after three days.

When the hysterical deductions of Miss Cheramie came true in Palms, the alarm was sounded (this is not reported in the documentation of Warren Commission); however, it was not possible to find her.

But, Garrison succeeded.

At the trial, and only at the trial, he will say how, when, and who killed Rose Cheramie on a highway near Dallas, a little after the assassination of Kennedy.

Thus, who says that the Kennedy case is "closed"?
