NEW ORLEANS TIMES-PICAYUNE IN ITS ISSUE OF DEC.  
TWENTYONE INSTANT REPORTED THAT EDGAR EUGENE BRADLEY WAS  
CHARGED WITH WILFULLY AND UNLAWFULLY CONSPIRING WITH OTHERS  
TO MURDER JOHN FITZGERALD KENNEDY BETWEEN AUG. ONE AND NOV.  
TWENTYTWO, THE DAY OF THE ASSASSINATION. THE ARTICLE  
REPORTED THAT THE CHARGE CARRYING A RECOMMENDED BOND OF  
TEN THOUSAND DOLLARS WAS FILED SHORTLY BEFORE FOUR PM ON  
WEDNESDAY IN CRIMINAL DISTRICT COURT BY ASSISTANT DA  
JAMES L. ALCOCK, WHO WAS ACCOMPANIED BY ASSISTANT DA RICHARD  
V. BURNES. ACCORDING TO THE ARTICLE WHEN ASKED WHETHER  
BRADLEY WAS IN NEW ORLEANS ALCOCK REPLIED, "WE KNOW WHERE  
HE IS. HE IS NOT IN NEW ORLEANS AND HE IS NOT FROM NEW

ORLEANS." ALCOCK REFUSED TO DISCUSS BRADLEY'S BACKGROUND AND TO GIVE ANY FURTHER DETAILS ON THE SUSPECT. THE ARTICLE REPORTED~~ED~~ THAT BRADLEY WAS CHARGED BY A DIRECT BILL OF INFORMATION AND MAY NOT HAVE BEEN IN THE STATE AT THE TIME.

THE ARTICLE REPORTED THAT THE NEW YORK TIMES IDENTIFIED BRADLEY AS LIVING IN NORTH HOLLYWOOD, CALIF. AND AS BEING THE WEST COAST REPRESENTATIVE FOR A DR. CARL MC INTIRE, A RIGHT WING EVANGELIST WHO LIVES IN NEW JERSEY. THE ARTICLE REPORTED THAT BRADLEY, REACHED BY TELEPHONE AT HIS HOME IN NORTH HOLLYWOOD, CALIF. BY THE ASSOCIATED PRESS, DENIED ANY KNOWLEDGE OF THE ASSASSINATION OR OF GARRISON'S INVESTIGATION. THE ARTICLE QUOTED BRADLEY AS SAYING, "THIS MAN IS EITHER BEING HIGHLY PAID TO DO THIS, OR HE IS OFF HIS ROCKER." THE ARTICLE STATED THAT THE FORTYNINE YEAR OLD BRADLEY SAID HE HAS WORKED OUT OF HIS HOME FOR FIVE YEARS AS WEST COAST REPRESENTATIVE OF DR. CARL MC INTIRE, A NEW JERSEY RADIO BROADCASTER.

ACCORDING TO THE ARTICLE BRADLEY ACKNOWLEDGED THAT MC INTIRE HAS BEEN DESCRIBED AS A RIGHT WING BROADCASTER BUT SAID HE, BRADLEY, WAS NEITHER A RIGHT WING EXTREMIST OR A LEFT WING EXTREMIST, THAT HE DID NOT BELONG TO A THING AND DOES NOT KNOW ANYTHING ABOUT GARRISON OR THE KENNEDY AFFAIR. BRADLEY ALSO DENIED THAT HE HAD EVEN BEEN IN NEW ORLEANS EXCEPT WHEN HE, HIS WIFE AND DAUGHTER RECENTLY VISITED HIS SON IN SCHOOL LAST MARCH OR APRIL WHEN THEY JUST DROVE THROUGH NEW ORLEANS.

THE ARTICLE ALSO REPORTED THAT BRADLEY SAID HE MOVED TO CALIF. IN NINETEEN THIRTY SIX AFTER GETTING OUT OF THE NAVY, AND DURING WORLD WAR TWO HE HAD A SPECIAL ASSIGNMENT FOR THE NAVY BUT DECLINED TO ELABORATE ON THIS ASSIGNMENT.

THE ARTICLE QUOTED WILLIAM GURVICH, A PRIVATE INVESTIGATOR WHO WAS FORMERLY GARRISON'S CHIEF AIDE IN THE KENNEDY DEATH PROBE, AS SAYING THAT HE DID NOT REMEMBER EVEN HEARING BRADLEY'S NAME. NO LHM BEING SUBMITTED.
