Believes the above three persons are currently in touch with him by some "machine transmission" and allegedly know what he is doing all of the time, including his present interview with an FBI Agent. The voices claim he knows too much and they are trying to "pervert" him by placing homosexuals at his disposal despite his abhorrence of such individuals.
