INFORMATION CONCERNING

[redacted] Seattle, Washington,
sent the following telegram to the U.S. Department of Justice,
Washington, D.C., on December 19, 1967:

"Have important information concerning death of
J.F.K. fast", signed [redacted] Seattle.

**RE: ASSASSINATION OF PRESIDENT
JOHN FITZGERALD KENNEDY**

In 1959 and 1960, he worked as a handy man for [redacted] who operates a restaurant at Rainier and Genesee [redacted]. He has not seen her since 1961. Just prior to the assassination of President JOHN F. KENNEDY, November 22, 1963, at Dallas Texas, he heard in his mind, a woman's voice. This voice sounded like that of [redacted] supra. The voice made several remarks to the effect "we will kill him" and "he will die". [redacted] attached no particular significance to this incident until recently. Wash

[redacted] claims that about one month ago he began having visions and hearing voices. His visions included [redacted] and one of her sons, [redacted]. The voices he hears are camouflaged but he is certain they are the voices of [redacted]. They are joined by a third voice alleged to be that of [redacted] President of The Boeing Company. [redacted] has never seen or met [redacted] is identified by name by the [redacted] in these voice transmissions. The messages indicated all three of the above individuals were in a conspiracy to kill President KENNEDY but [redacted] actually master minded it. None of these three individuals actually committed the assassination. [redacted] believes the above three persons are currently in touch with him by some "machine transmission" and allegedly know what he is doing all of the time, including his present interview with an FBI Agent. The voices claim he knows too much and they are trying to "pervert" him by placing homosexuals at his disposal despite his abhorrence of such individuals.
