You should inform Mr. LaCour that this data has been brought to the attention of the Attorney General by this Bureau and that this Bureau has also informed the Attorney General that we are not acknowledging Mr. Sciambra's letter and that we are taking no additional action concerning Mr. Sciambra's request.

You should follow this matter very closely with United States Attorney LaCour and keep the Bureau promptly informed of developments in this particular matter.

NOTE CONTINUED:

Jackson, Louisiana, claims he talked with Lee Harvey Oswald during the late Summer of 1963 and furnished such information to the Baton Rouge FBI Resident Agency. A check of our files disclosed no contact with Morgan regarding this matter and our investigation of the assassination disclosed no information Oswald ever met Morgan or ever was in Jackson, Louisiana, where Morgan allegedly claims he met Oswald. We have previously informed the Department and United States Attorney LaCour of this situation.
