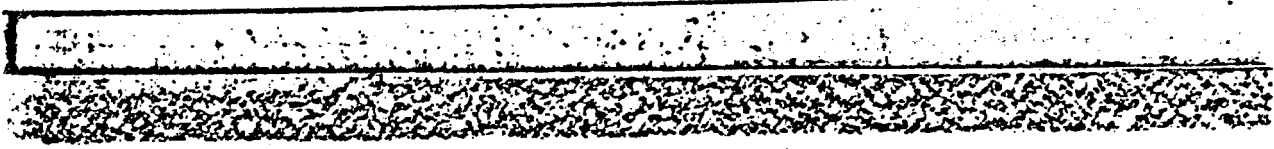

SUBPOENAS ISSUED BY THE DA'S OFFICE FOR THE GRAND JURY IN THE INVESTIGATION, COPY OF AN INVESTIGATIVE REPORT DEALING WITH ALLEGED BATTERY ON JIM HICKS, AN OUT-OF-STATE WITNESS AND COPY OF ALL CORRESPONDENCE BETWEEN GARRISON AND JERRY FOOTLICKE, AUTHOR OF A STORY IN THE NATIONAL OBSERVER.

THE ARTICLE REPORTED THAT THREE NEW WITNESSES WERE SUBPOENAED AT THE REQUEST OF THE DEFENSE AND IDENTIFIED THESE WITNESSES AS LINDSEY RIDDLE, WDSU, FRANCIS JACOB, WVL AND ALLAN ANDERSON, WVUE.

ACCORDING TO THE ARTICLE JUDGE HAGGERTY SAID ALL OF THE PERSONS AFFECTED BY THE SUBPOENAS CAN COME INTO COURT TUESDAY AND CONTEST THEM IF THEY FEEL THEY ARE OPPRESSIVE OR UNREASONABLE.
