MR. GUY WOOTAN, ATTORNEY, NATIONAL BANK OF COMMERCE BLDG.,
APPEARED AT USA LACOUR'S OFFICE WITH MR. WALTER ON MARCH
FIFTEEN LAST AS HIS ATTORNEY.

MR. WOOTAN WAS CONTACTED THIS AFTERNOON BY SAC RIGHTMYER
WITH REFERENCE TO PRESENT LOCATION OF MR. WALTER. MR. WOOTAN
ADVISED THAT MR. WALTER IS IN CONSTANT TRAVEL STATUS OUTSIDE
THE STATE OF LOUISIANA AND RETURNS HERE ONLY OCCASIONALLY.
MR. WOOTAN ADVISED HE HAD NO IDEA HOW HE COULD CONTACT MR.
WALTER BUT THAT WALTER NORMALLY TELEPHONES HIM AT LEAST ONCE
A WEEK. MR. WOOTAN STATED THAT HE WOULD IMMEDIATELY ADVISE ME
OF MR. WALTER'S LOCATION JUST AS SOON AS HE HEARD FROM WALTER.

AT THE TIME MR. WALTER WAS INTERVIEWED BY SAC, JACKSONVILLE,
HE GAVE AS HIS ADDRESS ONE FIVE THREE THREE JACKSON AVE., NEW
ORLEANS, LA. INVESTIGATION AT THIS ADDRESS REVEALS THAT MR.
