TO PO BOX SEVEN TWO ZERO FOUR, NASHVILLE, TENN.

PERSONNEL RECORDS UNIT

FOR THE INFORMATION OF MEMPHIS, REBURAD ADVISED THAT THE SAC  
WITH A MATURE EXPERIENCED AGENT, WAS TO PERSONALLY INTERVIEW WILLIAM S.  
WALTER, A FORMER CLERICAL EMPLOYEE OF THE NEW ORLEANS DIVISION, AND  
PIN HIM DOWN IN REGARD TO HIS ALLEGATIONS. MR. WALTER WAS TO BE INFORMED  
OF HIS RIGHTS IN ACCORDANCE WITH CURRENT BUREAU PROCEDURES AND ALERT HIM

TO THE PROVISIONS OF TITLE EIGHTEEN, SECTION ONE ZERO ZERO ONE RELATING TO FURNISHING FALSE INFORMATION TO A U. S. GOVERNMENT AGENCY.

DURING THE INTERVIEW YOU SHOULD OBTAIN A SIGNED STATEMENT FROM WALTER WHEREIN HE SETS FORTH COMPLETE DETAILS CONCERNING THE ALLEGATIONS INVOLVING AN FBI COMMUNICATION TO NEW ORLEANS AND OTHER OFFICES ON NOVEMBER ONE SEVEN, SIX THREE, ALLEGEDLY STATING THERE WOULD BE A THREAT TO PRESIDENT KENNEDY IN CONNECTION WITH PRESIDENT KENNEDY'S TRIP TO TEXAS.

COPIES OF RE COMMUNICATIONS ARE BEING FORWARDED AMSD TO MEMPHIS WITH COPIES OF LHM DATED FEBRUARY TWO, LAST, FEBRUARY FIVE, LAST AND MARCH TWO ZERO, LAST, FOR BACKGROUND INFORMATION. THE INFORMATION REGARDING THE CHANGE OF ADDRESS OF WALTER WAS TELEPHONICALLY FURNISHED MEMPHIS ON MARCH TWO FIVE, INSTANT.

MEMPHIS'S ATTENTION IS AGAIN DIRECTED TO BUREAU INSTRUCTIONS THAT THIS INTERVIEW IS TO BE PERSONALLY CONDUCTED BY THE SAC.
