ON JULY 1, 1975, INVESTIGATOR EDWARD ROEDER, HOUSE SELECT COMMITTEE ON INTELLIGENCE, TELEPHONICALLY CONTACTED THE WILMINGTON, DELAWARE RESIDENT AGENCY AND REQUESTED INFORMATION CONTAINED IN REFERENCED COMMUNICATION. THIS LHM SETS FORTH ALLEGATIONS MADE BY [REDACTED]

[REDACTED], WILMINGTON, DELAWARE, MADE TO BUREAU AGENTS ON JULY 28, 1971, THAT CIA EMPLOYEES HAD GIVEN HER AN AMNESIC TYPE DRUG AND COMMITTED INDISCREET SEXUAL ACTS UPON HER WHILE UNDER THE INFLUENCE OF DRUGS.

INVESTIGATOR ROEDER ADVISED HE HAD INTERVIEWED [REDACTED] ON JULY 1, 1975 AND DESIRED TO COMPARE ALLEGATIONS MADE ON JULY 28, 1971 WITH THOSE ALLEGATIONS SHE CONTINUED
