INFORMATION RE ASSASSINATION OF PRESIDENT JOHN F. KENNEDY.
FOLLOWING RECEIVED FROM LEGAT [REDACTED]
ON AUGUST 7, 1975, U. S. VICE CONSUL [REDACTED]

[REDACTED], ADVISED THAT [REDACTED], A U. S.
CITIZEN CONDEMNED TO DEATH FOR MURDER IN [REDACTED] ON
JULY 18 LAST VERBALLY RELATED TO [REDACTED] THAT HE HAD
DELIVERED MONEY TO LEE HARVEY OSWALD A FEW DAYS BEFORE THE
ASSASSINATION OF PRESIDENT JOHN KENNEDY AND HAD ALSO
DELIVERED MONEY TO SIRHAN SIRHAN JUST PRIOR TO ASSASSINATION
OF SENATOR ROBERT KENNEDY. [REDACTED] RETRACTED THE STORY ABOUT
SIRHAN BUT INSISTED THE OSWALD CONTACT WAS TRUE.

[REDACTED] WAS SCHEDULED FOR EXECUTION IN [REDACTED] ON
JULY 22 BUT RECEIVED REPRIEVE ON NIGHT OF JULY 18.
HIS FATE IS NOW ON APPEAL TO QUEEN OF ENGLAND BUT EVEN
IF EXECUTION IS COMMUTED HE FACES LONG IMPRISONMENT.

VICE CONSUL [REDACTED] TOLD [REDACTED] TO WRITE STATEMENT
DETAILING CIRCUMSTANCES OF OSWALD CONTACT. [REDACTED] DELIVERED
SUCH STATEMENT TO [REDACTED] ABOUT AUGUST 1. THIS STATEMENT

██████████ IN NOVEMBER, 1963, WAS EMPLOYED BY C & H TRANSPORTATION COMPANY AT DALLAS, TEXAS. HE RECEIVED CALL FROM HIS FORMER EMPLOYER EBB ROSE, SON OF ██████████ TO PROCEED TO ██████████ TRUCKING OFFICE IN HOUSTON. THERE ON A FRIDAY NIGHT HE CONFERRED WITH EBB ROSE, ATTORNEY (FNU) SCOTT FROM FORT WORTH, AND PERSON KNOWN AS WEBBY. ROSE AND SCOTT TOLD ██████████ HE WAS TO DELIVER MONEY FOR A QUOTE HIT UNQUOTE AND THAT ONE JAMES HOLLAND OR LEE OSWALD WOULD CALL HIM AT WORK IN DALLAS TO ARRANGE FOR DELIVERY OF MONEY. ROSE GAVE ██████████ AN ATTACHE CASE WITH MONEY AND \$3,000 IN LOOSE 100 BILLS AS MOORE'S PAY. THE FOLLOWING WEEK OSWALD CALLED ██████████ TO MEET AT A LIQUOR STORE, POSSIBLY CENTENNIAL LIQUOR STORE, ON HIGHWAY 183, DALLAS. ██████████ GAVE OSWALD HIS LICENSE NUMBER AND HOLLAND AND OSWALD AFTER LOCATING ██████████ HAD HIM FOLLOW THEM IN THEIR 1961 WHITE CHEVROLET, RED INTERIOR, TO A MOTEL ON THE HARRY HINES BOULEVARD TRAFFIC CIRCLE.

THE MOTEL IS LOCATED ACROSS FROM A RESTAURANT BUILT LIKE A SHIP. IN THE MOTEL ██████████ DUMPED THE MONEY FROM THE

ATTACHE CASE ONTO A BED.

OSWALD COUNTED THE MONEY WHICH AMOUNTED TO 100,000 DOLLARS IN FIFTIES AND HUNDREDS IN BANK WRAPPERS. HOLLAND REMARKED QUOTE THIS WAS THE DOWN PAYMENT LEE BABY UNQUOTE. A FEW DAYS LATER [REDACTED] SAW OSWALD ON TV COVERAGE.

INTERVIEW BY LEGAT REPRESENTATIVES ON AUGUST 8 LAST, [REDACTED] SAID HE WAS QUOTE SCRAMBLING ENQUOTE WHEN HE TOLD OF SHIRHAN CONTACT BUT OSWALD STORY IS TRUE. HE NEVER MENTIONED IT UNTIL HE TOLD VICE CONSUL [REDACTED] AS HE WAS SET TO DIE ON JULY 22 AND WANTED TO CLEAR HIS CONSCIENCE. HE SAID WEBBY IS 55 TO 60 YEARS OLD NOW, BIG BUILD. HE KEPT ATTACHE CASE RECEIVED FROM ROSE UNTIL 1972 WHEN LEFT IT AT PASADENA, TEXAS, RESIDENCE OF ELDERLY WOMAN WHO BABYSAT FOR CHILDREN OF [REDACTED] GIRLFRIEND [REDACTED]

[REDACTED] CLAIMED ROY HILLIARD, FORMER TEXAS HIGHWAY PATROLMAN EMPLOYED BY [REDACTED], WHO KNEW MOORE IN SPIR, TEXAS, HAD INFORMED EBB ROSE OF [REDACTED] CRIMINAL BACKGROUND, THUS, PRESUMABLY, RESULTING IN SELECTION OF
