ADVISED THAT HE HAS LOCATED HIS COPY OF THE ABOVE NAMED DOCUMENTS AND THAT HE WILL MAKE THEM AVAILABLE FOR REVIEW BY THE FBI IN A "COUPLE OF DAYS."

ON MARCH 22, 1977, [REDACTED], IRS INTELLIGENCE, DALLAS, ADVISED THAT HE HAS NOT HEARD ANYTHING FROM THE IRS HEADQUARTERS DISCLOSURE OFFICE CONCERNING THE RELEASE OF ANY ADDITIONAL DOCUMENTS TO THE FBI. [REDACTED] SENT APPROXIMATELY ONE HALF INCH OF COPIES OF DOCUMENTS TO THE HEADQUARTERS DISCLOSURE OFFICE TO REVIEW AND KEPT A COPY OF THESE DOCUMENTS AT DALLAS. THESE DOCUMENTS CONSIST OF IRS MEMORANDA AND OTHER MISCELLANEOUS DOCUMENTS THAT HE PULLED FROM THE IRS FILES THAT MIGHT HAVE SOME BEARING ON THE ALLEGATIONS AS SET FORTH IN HIS MEMORANDUM OF DECEMBER 9, 1976. HE DOES NOT KNOW WHAT THE RELEASE AUTHORIZATION HOLDUP IS, BUT HE KNOWS THAT THE "HEAT" IS ON AT IRS HEADQUARTERS SINCE THEY ARE ALSO PROCESSING A U. S. SENATE REQUEST FOR THE SAME INFORMATION. HE ADVISED THAT THE DOCUMENTS HE SUBMITTED WILL NOT SHED ANY ADDITIONAL LIGHT ON THE ALLEGATIONS.

HE WILL CALL IRS HEADQUARTERS TO SEE IF HE CAN EXPEDITE THE RELEASE OF DOCUMENTS TO THE FBI AND, UPON OBTAINING ANY

PERTINENT INFORMATION, WILL ADVISE THE DALLAS FBI. HE WILL NOT RELEASE ANY DOCUMENTS OR MORE SPECIFIC INFORMATION WITHOUT WRITTEN AUTHORIZATION FROM IRS HEADQUARTERS.

ON MARCH 21, 1977, [REDACTED] DALLAS, TEXAS, TELEPHONICALLY CONTACTED THE DALLAS OFFICE AND ADVISED THAT HE WANTED HIS BULLET BACK AS SOON AS POSSIBLE, WHICH HE MADE AVAILABLE TO THE FBI ON DECEMBER 1, 1976. [REDACTED] ADVISED THAT THE LABORATORY EXAMINATION ON HIS BULLET SHOULD HAVE BEEN COMPLETED BY NOW AND THAT HE WANTS TO BE ADVISED OF THE STATUS OF HIS PROPERTY. THE INTERVIEW WITH [REDACTED] SET FORTH IN DALLAS LHM DATED JANUARY 10, 1977.

DALLAS AT MIDLOTHIAN, TEXAS. WILL RECONTACT WILLIAM PENN JONES AND REVIEW HIS COPY OF THE NOVEMBER 8, 1963 LETTER AND RELATED DOCUMENTS AND IF POSSIBLE, OBTAIN CUSTODY OF SAME FOR POSSIBLE FBI LABORATORY EXAMINATION.

DALLAS WILL MAINTAIN CONTACT WITH [REDACTED] IRS, RE RELEASE OF ANY ADDITIONAL DOCUMENTS.

THE BUREAU IS REQUESTED TO ADVISE DALLAS OF THE STATUS OF THE FBI LABORATORY EXAMINATION ON THE ALLEGED BULLET FURNISHED
