EDWARD P. EPSTEIN IN RE-INTERVIEW, MARCH 31, 1977,

ADVISED THAT DURING LENGTHY INTERVIEW NIGHT OF MARCH 29, 1977
WITH STATES ATTORNEY DAVID BLUDWORTH AND OFFICERS OF PALM BEACH
COUNTY SO, HE MAY HAVE INDICATED THAT GEORGE DE MOHRENSCHILDT
INDICATED HE HAD MANEUVERED LEE HARVEY OSWALD AND CLAIMED TO
HAVE PUT OSWALD IN TOUCH WITH THE "RIGHT PEOPLE," HOWEVER,
HE WISHED TO CLARIFY THIS STATEMENT. EPSTEIN STATED IN
DEALINGS WITH DE MOHRENSCHILDT HE DID NOT EVER INDICATE THAT

HE HAD PUT OSWALD IN TOUCH WITH POTENTIAL ASSASSINS, BUT HE INDICATED TO EPSTEIN HE WAS VERY FOND OF OSWALD AND CLAIMED TO HAVE PUT HIM IN TOUCH WITH AND INTRODUCED HIM TO PEOPLE THAT COULD HELP HIM. EPSTEIN STATED HE GATHERED FROM DE MOHRENSCHILDT'S REFERENCES TO THESE OCCASIONS THAT HE HAD INTRODUCED HIM TO BUSINESS PEOPLE, PEOPLE INVOLVED IN EDUCATION, JOB PROSPECTS AND THE LIKE. EPSTEIN REPEATED THAT AT NO TIME DID HE GET THE IMPRESSION FROM DE MOHRENSCHILDT'S REMARKS THAT HE HAD EVER INTRODUCED HIM TO TERRORISTS, POTENTIAL ASSASSINS OR INDIVIDUALS ADVOCATING OVERTHROW OF THE GOVERNMENT.

EPSTEIN ADVISED THAT HE IS NOW RESCHEDULING HIS DEPARTURE DATE FROM WEST PALM BEACH, FLORIDA UNTIL APRIL 1, 1977 AS DE MOHRENSCHILDT'S DAUGHTER, ALEX, HAS CONTACTED HIM AND DESIRES TO TALK TO HIM. EPSTEIN ADVISED HE WILL CONTACT THE FBI EARLY APRIL 1, 1977 WITH ANY DEVELOPMENTS OBTAINED FROM ALEX RE DE MOHRENSCHILDT.
