It is noted that [REDACTED] newspaper reporter, whose interviews are recorded in two attached 302s, requested that his name only be protected. Therefore, in any incorporation of these 302s into report form will require that [REDACTED] name be omitted and that he be characterized as a person who is in a position to know.

NOTE: George DeMohrenschildt, an associate of Lee Harvey Oswald, apparently committed suicide on 3/29/77, in Manalapan, Florida. [REDACTED]

[REDACTED] In this interview Oltmans discusses his relationship with DeMohrenshildt and claims that in statements to him DeMohrenschildt says he was responsible for Oswald's actions. Purpose of this airtel is to forward to Dallas results of FBIHQ investigation.
