You have committed a murder. I hope that you will write to me in your spare time, but even more I hope you win your trial. If you have time to write again, would you please answer these questions?

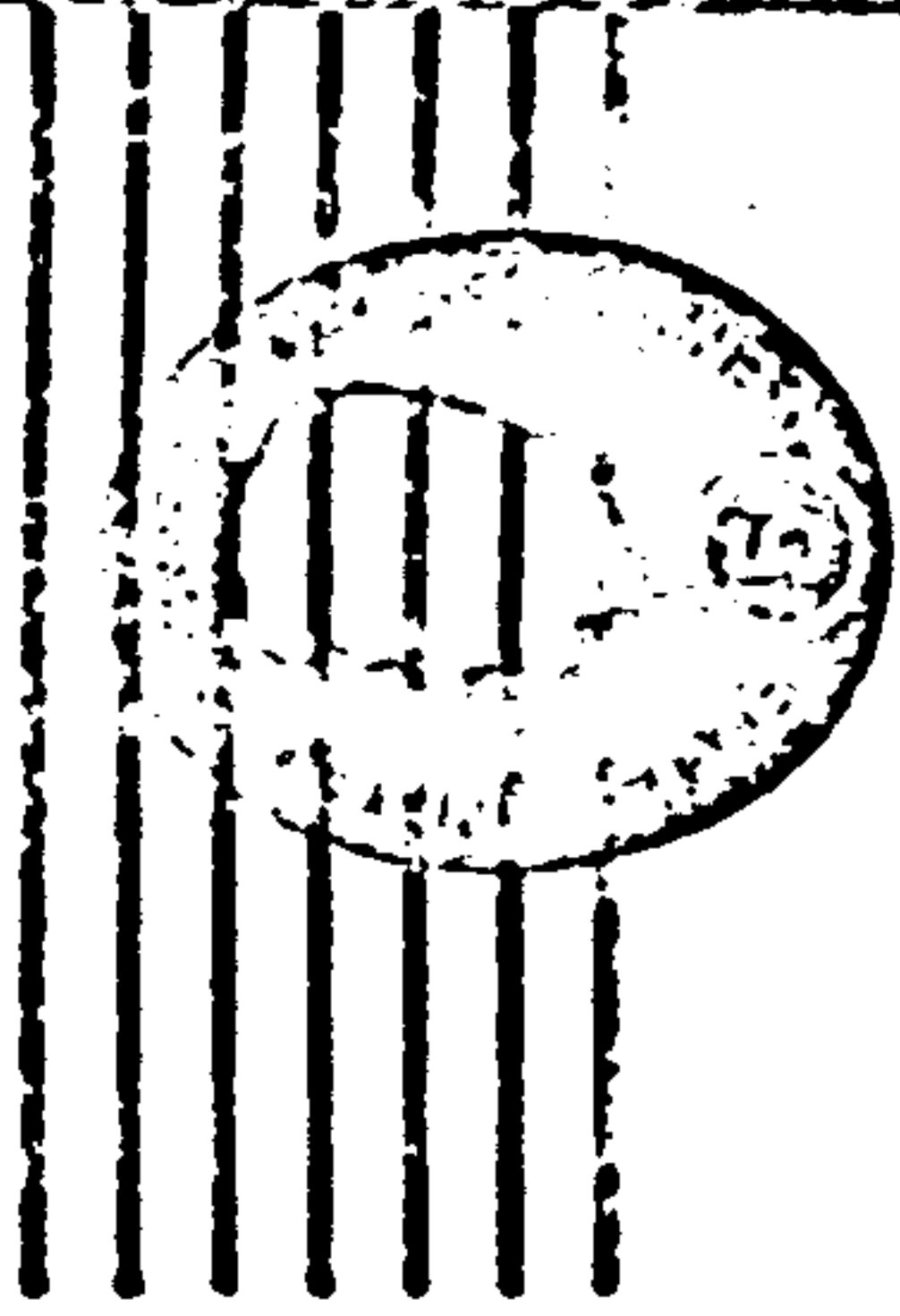

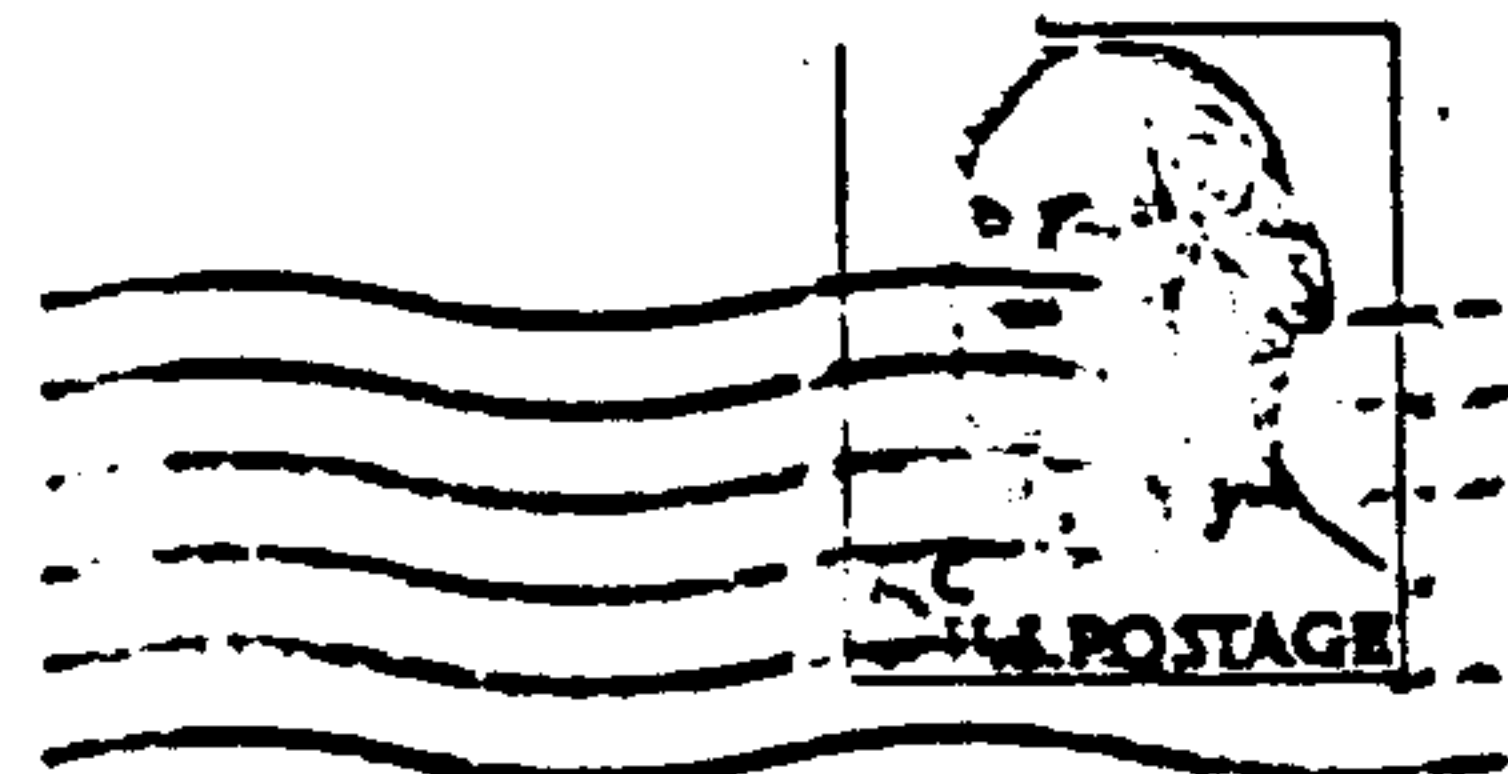
Dear Mr. Ruby,

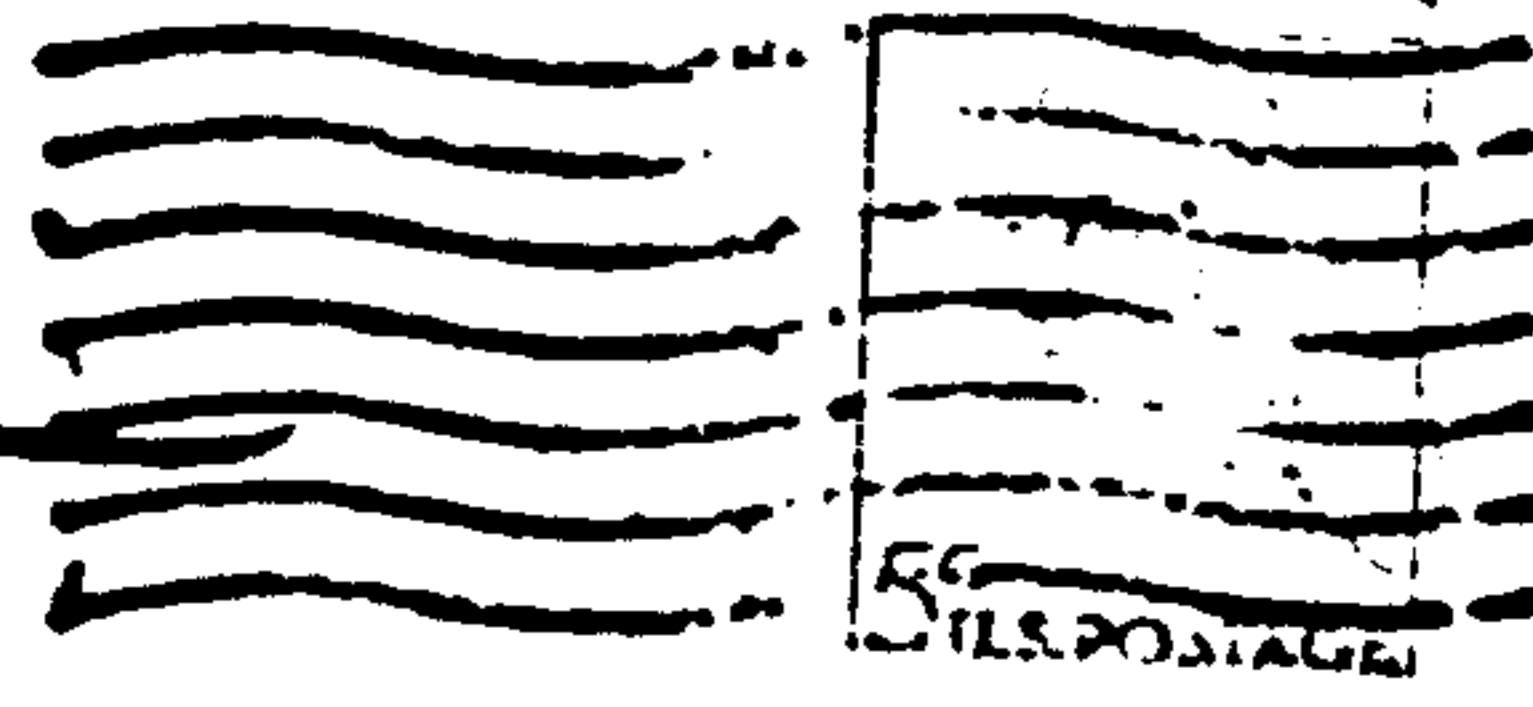
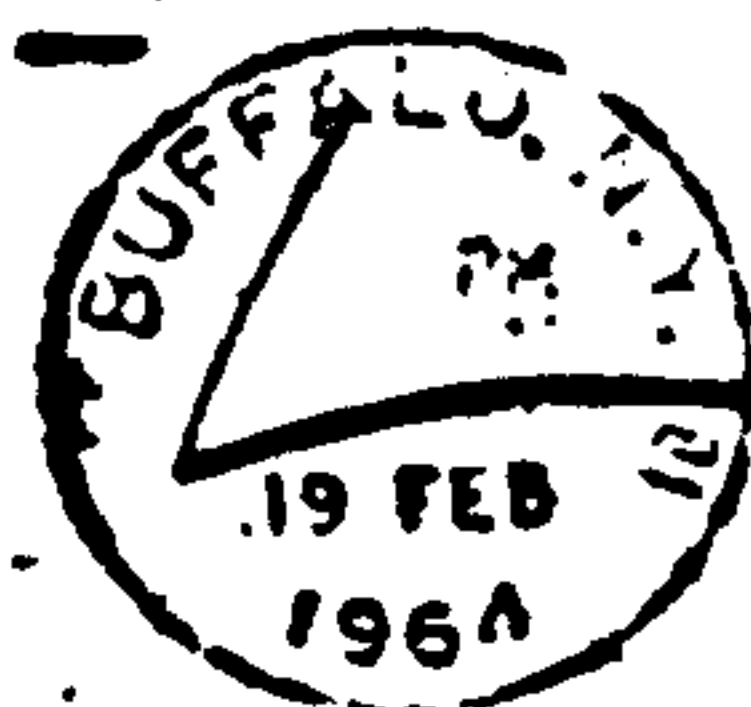

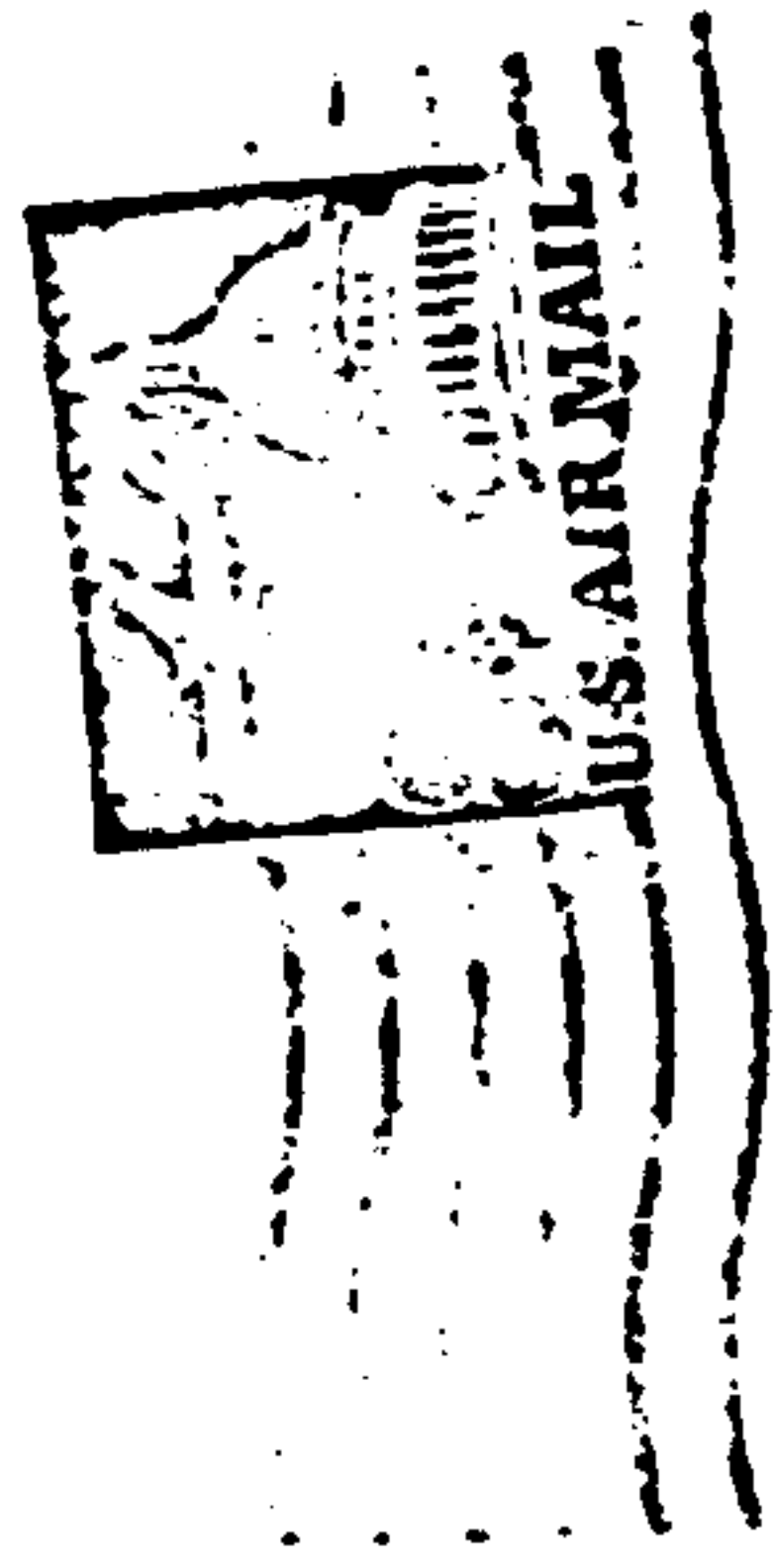
