The Verdict Is Death

Jack Ruby took the law into his own hands in snuffing out the life of Lee Harvey Oswald. He did so with premeditation. The fact that the man he killed was charged with the murder of a President did not in any way decrease the magnitude of his offense.

His lawyers had only two lines of defense open to them. First, there was the attempt to force a change of venue by showing that Dallas could not give Ruby a fair trial. Despite their circuitous tactics an intelligent and responsible group of jurors was impaneled. As for the trial itself, it centered on a "temporary insanity" plea, in which the evidence from defense witnesses was countered, as customary in such cases, by expert testimony for the prosecution.

All the defense proved was that Ruby is an unstable character; very few murderers would suffer as result of their deeds if that were grounds enough for acquitting them. The jury returned its verdict with such speed as to indicate little doubt or disagreement among its members.

The defense attorney's arguments to

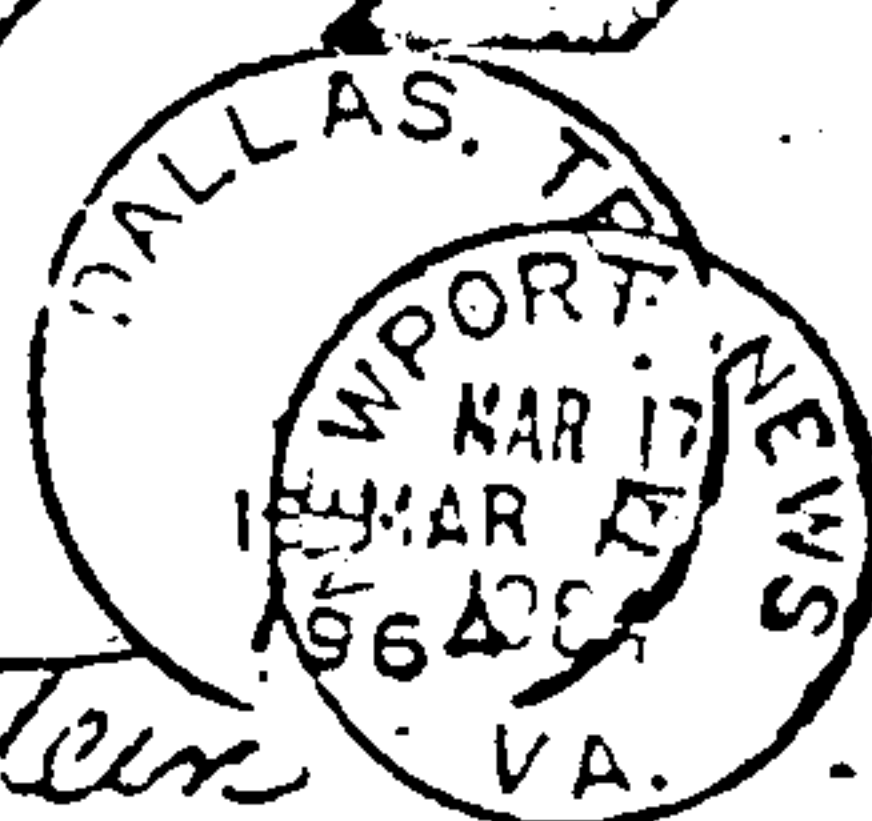
the contrary, there is no reason to think the decision—death in the electric chair—would have been different if the trial had been held in any other city.

Ruby had recourse to the services of an able battery of lawyers; they used every trick in the book. They haven't exhausted their repertoire yet; already it has been announced, as expected, that there will be an appeal. Perhaps years will elapse before the courts finish with this case; the question of whether there was reversible error is something that the legal minds will have to decide and it should take them a long time to do so.

However, what that Dallas jury did was what had to be done. If Ruby had been acquitted or let off with a light sentence, that would have been an open invitation to others to mete out "justice" with their own hands in accordance with their own twisted views. Ruby also performed a disservice to the nation and to the world by preventing a trial of Lee Harvey Oswald, which would have given a better idea than can now be gained of why he committed his unthinkable act.
