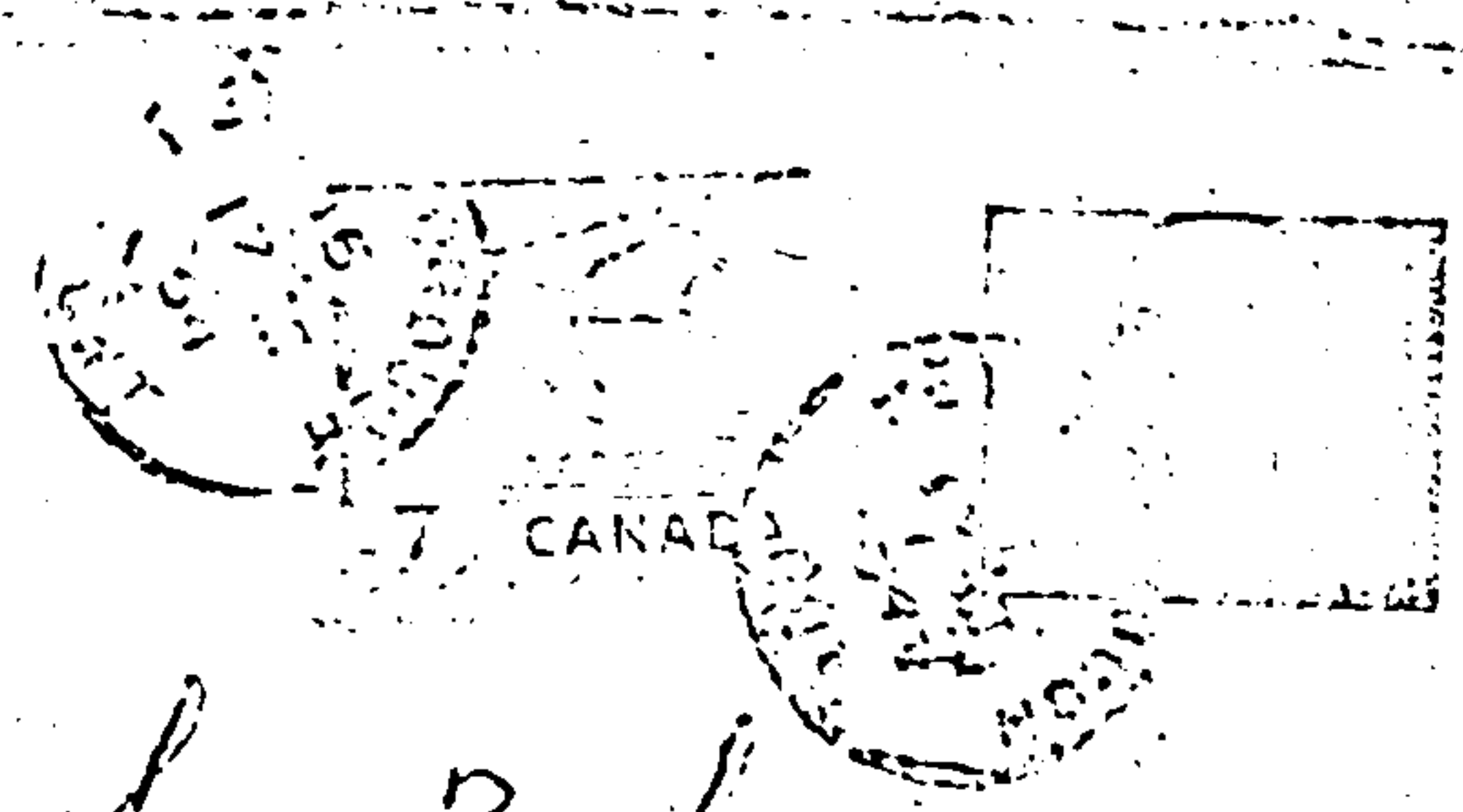

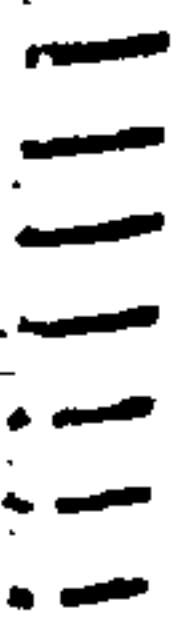

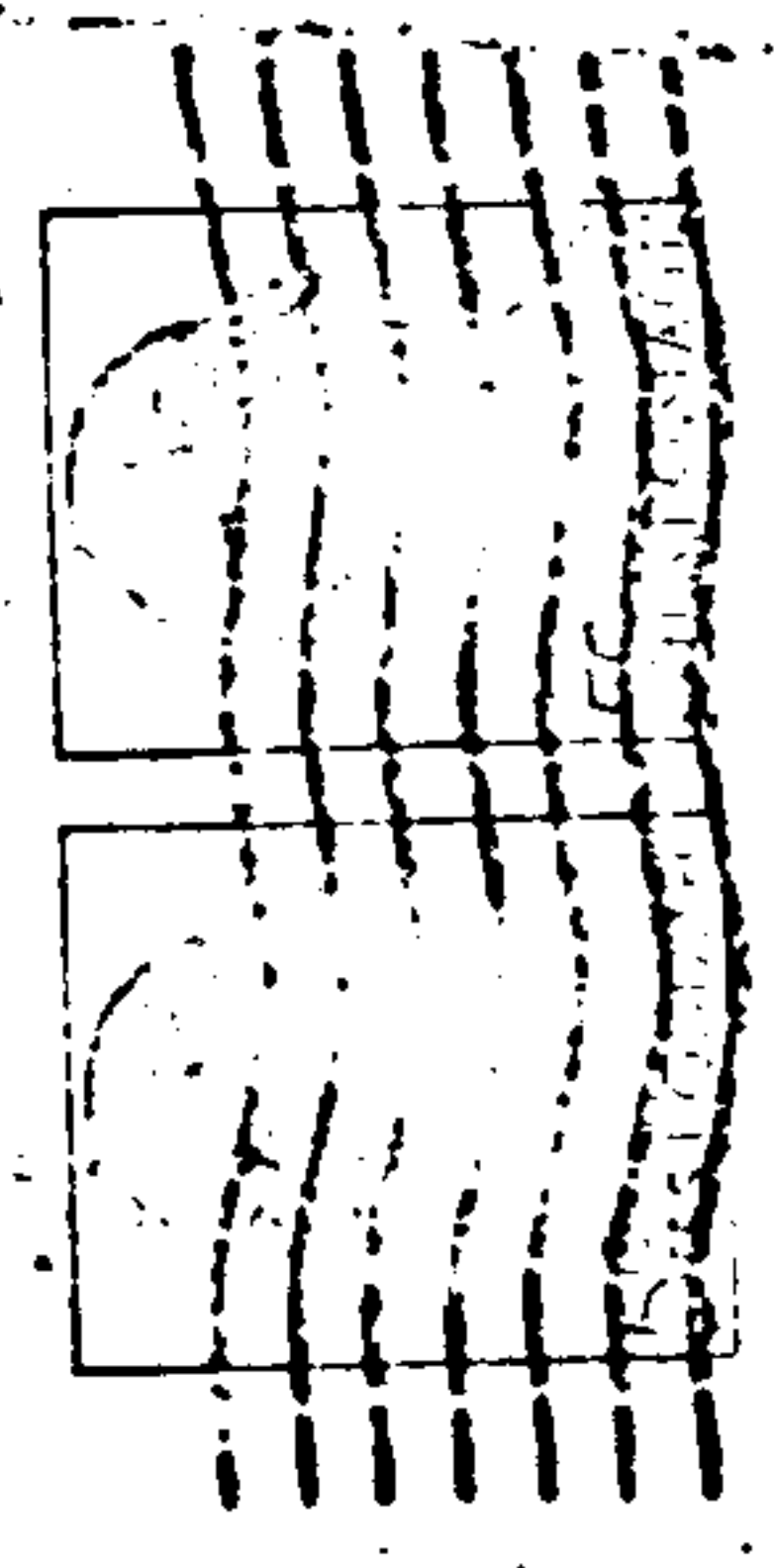
Dear Mr. Ruby,
