Dear Mr. Ruby,

I was shocked, disappointed, and infuriated upon hearing of your unjust verdict last Saturday. I will never understand why your trial wasn't held somewhere else with an unprejudiced jury.

November 22, 1963 was a day that will remain clear in my mind for many years past this one (my seventeenth.) How could anyone alive ever forget the day that we were deprived forever more of one of the greatest men who had ever lived--John F. Kennedy. Most of the world was outraged and deeply grieved upon hearing of this tragedy, but some people aren't as strong as others; likewise, some are more emotional. You, as did all of us, loved this man, and his incredulous death was probably more than a highly emotional patriotic man like yourself, could bear.

I am sure that what you must be going through now is far worse than any further punishment that could be put upon you. You are the one who will have to bear the heavy burden of a tortured conscience for the rest of your life. There could be no worse punishment than those that man inflicts upon himself, and no worse torture than having to face oneself in a cold prison cell.

You can still find some people in Dallas who believe in justice and the democratic way of life. The bulk of public opinion is on your side. I only hope that our letters and words of encouragement have helped somewhat, and I hope that the facts presented in your case will convince the next jury of forming a fair verdict.

All that you can do now is to keep your chin up and don't lose faith in your lawyers, people, and God. He knows who's right, and your prayers and ours will all help to make the next judgment a victory. May God be with you!

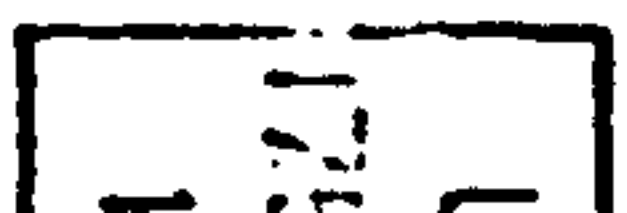
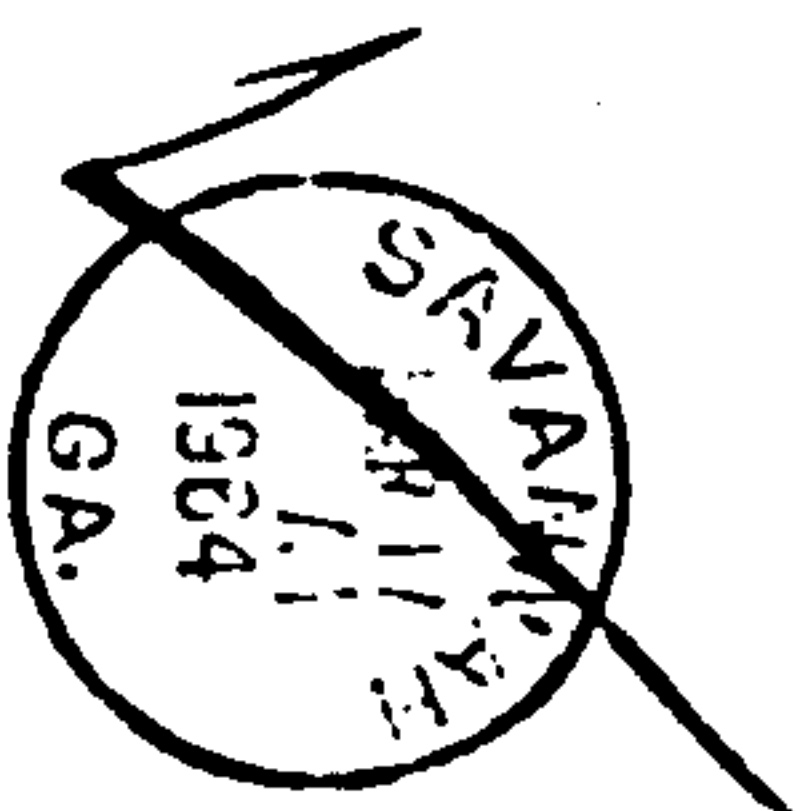

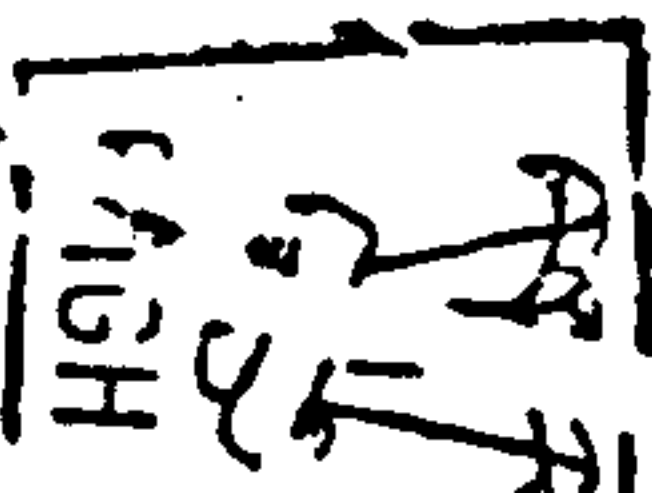
