PURPOSE:

The purpose of this memorandum is to request that SA Regis L. Kennedy (former) be released from his employment agreement for the purpose of interview and testimony by captioned Committee on 12/30/77.

DETAILS :

James Wolff of the Legal staff for captioned Committee advised SA Danny O. Coulson that the Committee desired to interview at an early date the case agent in the investigation of Carlos Marcelo for the period of 1960-1964. A review of appropriate documents at FBI Headquarters and contact with the New Orleans Division has indicated that case agent is Regis L. Kennedy (former) who is currently engaged in a law practice in New Orleans, Louisiana. A letter will be forthcoming from the Committee requesting interview of SA Kennedy.

RECOMMENDATION:

The Committee's attention is being directed to the fact that these booklets contain information that proved to be incomplete or erroneous in the light of subsequent investigation or inquiry conducted by the FBI, other agencies and the Warren Commission after January 13, 1964. However, all information set forth in them was based on the best data available at the time the booklets were prepared for dissemination.

When you approved, an FBI representative will deliver copies of the five requested briefing booklets to the HSCA. Only third agency material has been excised or deleted.

This matter has been coordinated with the Legal Liaison NOTE: and Congressional Affairs Unit (LLCA), Legal Counsel Division, with the Document Classification Office, Records Management Division, and with Assistant Attorney General Robert L. Keuch. Review of material to be delivered disclosed no necessity to classify any elements of information therein and Mr. Keuch agrees with the thrust of this response and the mode of delivery. The five enclosures are detached because of their bulk and are to be delivered directly to the Committee by a representative of the LLCA Unit when approved by Mr. Keuch. The material to be delivered consists of an FBI summary report prepared during the first week of December, 1963, a supplemental report dated January 13, 1964, and three volumes of exhibits. The file discloses this material was originally prepared for and disseminated to the White House, Warren Commission and prominent Bureau and Government officials. Only third agency information and documents are now being excised and deleted respectively. While the third agency is identified in each instance, it is felt that this Bureau should not be required to go further and identify the proper persons in each agency to which requests should be directed for the information or documents.

Volume Y - "Investigation of Assassination of President John 7. Kennedy, November 22, 1963 - Exhibits, Volume III."

Only information and documents obtained by the Val from other agencies have been excised or deleted from these booklets; however, in each instance the source agency has been identified to assist the Committee should it choose to contact the source agencies directly.

It must be noted that a review of these booklets discloses some information that has since been shown to be incomplete or erroneous in light of subsequent investigation or inquiry conducted by the FBI, other agencies and the Warren Commission after the booklets were prepared.

An example of incomplete and erroneous information may be found in Volume I, page 18, (prepared approximately December 5, 1963, and prior) where it is stated:

> ". . Medical examination of the President's body revealed that one of the bullets had entered just below his shoulder to the right of the spinal column at an angle of 45 to 60 degrees downward, that there was no point of exit, and that the bullet was not in the body. . . "

Commenting on this same wound in 1964, the "Report of the President's Commission on the Assassination of President John F. Kennedy," on Page 60 stated:

> "The autopsy also disclosed a wound near the base of the back of President Kennedy's neck slightly to the right of his spine. The doctors traced the course of the bullet through the body and, as information was received from Parkland Hospital, concluded that the bullet had emerged from the front portion of the President's neck that had been cut away by the tracheotomy at Parkland. ..."

House Select Committee on Assassinations

In 1958, a panel of prominent physicians reviewed photographs, X-ray films, documents and other evidence pertaining to the assassination of President Kennedy and stated as follows with regard to the President's back wound:

> "The other bullet struck the decedent's back at the right side of the base of the neck between the shoulder and spine and emerged from the front of his neck near the midline. ..."

It must also be noted, however, that the information contained in these booklets is based on the best data available to the YBI at the time each booklet was prepared.

During June, 1977, Committee representatives were advised that the WBI never possessed an original of the letter allegedly written by Oswald to a Mr. Hunt. At this time, Committee representatives were granted access to and did review the volume containing an PBI Laboratory report, dated April 18, 1977, which stated that Item 2 consisted of "two photographs of photocopy of handwritten letter dated 11/8/63, beginning 'Dear Mr. Hunt,' and signed 'Lee Harvy Oswald.'"

In effect, therefore, the FBI examined photographs of a photocopy of the letter in question. At no time did the FBI possess the original of a letter allegedly written by Oswald to a Mr. Hunt. The photocopy was in the possession of

PURPOSE:

The purpose of this memorandum is to establish procedures for handling requests from captioned committee fat will reveal information furnished to the FBI by foreign governmental agencies.

DETAILS:

The Congressional Inquiry Unit of the Special Investigative Division has raised a question with the Legal Counsel Division as the the proper procedure of handling requests that will reveal information furnished to the FBI by foreign governmental agencies. It should be noted that 'in many cases foreign governmental agencies have advised the FBI that they do not want to be identified as having furnished information to the FBI on a confidential basis. In view of this fact it is felt that procedures for handling these requests must be established that differ from procedures that are used where U.S. governmental agencies have furnished information to the FBI. In dealing with information supplied by other U.S. governmental agencies the committee is advised that the requested information has been received from another governmental agency, the agency is identified and the committee is referred to that agency for access to the information. It is Legal Counsel's opinion that where the request would reveal information from a foreign governmental agency, the material should be deleted in its entirety and the committee should only be advised that the information came from a foreign governmental agency. When the committee requests the identity of the foreign governmental agency or the specific information, the FBI through the Liaison Unit, Intelligence Division will ascertain from the governmental agency its views regarding furnishing the identity of the agency and the information requested.
