PURPOSE: To furnish advice as to whether handwritten notes made by Mr. Blakey during his review of certain FBI files and retained at FBIHQ per Mr. Blakey's request, are "agency records" subject to the FOIA.

DETAILS: The reach of the FOIA is restricted by the language of the statute to the Executive Branch of the Federal Government. Congress is clearly not an "agency" within the meaning of the statute, and therefore records compiled by Congress or Congressional employees do not fall within the scope of the FOIA. Nor does it appear that Congressional records are brought within the FOIA by virtue of being within the possession of an "agency" whose records are in fact accessible under the statute. In Goland v. CIA, et al., (No. 76-0166, D.D.C. 1976), the Court held that a Congressional document, released to the CIA for limited purposes "as a reference document only," was still within the control of, and retrievable by, Congress and, therefore, not subject to disclosure under the FOIA.

Mr. Blakey's notes were made pursuant to his duties as Chief Counsel of HSCA. Apparently, for reasons of security or convenience, or both, Mr. Blakey requested that the notes be retained at FBIHQ until he has further need of them in preparing HSCA's final report. Therefore, the notes should not be considered agency records but rather Congressional documents within control of, and retrievable by, the Congress.
