SUBJECT: REQUEST BY HOUSE SELECT COMMITTEE ON ASSASSINATIONS  
FOR RETURN OF FINGERPRINT CARDS ON STAFF MEMBERS

PURPOSE: To record action taken on captioned matter.

DETAILS: On 6-28-78 Mr. Robert C. Morrison, Director of Security, House Select Committee on Assassinations, visited the Identification Division accompanied by SA Ronald Heller, Legal Liaison and Congressional Affairs Unit. Mr. Morrison brought with him a copy of a letter dated 6-27-78 (attached) to the Attorney General from the Chairman of the Committee requesting the temporary return of fingerprint cards on ten (10) Committee staff members which had previously been furnished to the FBI in connection with background security checks on those persons.

A search of Identification Division files using the name and dates and places of birth furnished by Mr. Morrison resulted in the location of eight (8) of the fingerprint cards (as indicated on the attached "Notice of Receipt of Fingerprint Cards") which were returned to Mr. Morrison. Fingerprint cards were not located for Edwin Juan Lopez and Betty Lou Sisson. It was explained to Mr. Morrison that, although no fingerprint cards were located for these people on the basis of name searches, the only way to conclusively determine whether fingerprint cards are or are not contained in the Identification Division's files is through a fingerprint search. Therefore, it was suggested that Mr. Morrison furnish inked fingerprints of the two individuals, which would be used to search the files. He was told that the Identification Division would be willing to fingerprint Lopez and Sisson, or they could be fingerprinted elsewhere as long as the prints are properly taken. Mr. Morrison indicated that they would probably be fingerprinted elsewhere. He was furnished blank fingerprint cards for that purpose.

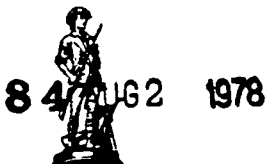

[REDACTED] House Select Committee on Assassinations (HSCA) after being advised of the identities of the interviewing Agents, the nature of the interview and her Constitution Rights as set forth on a Waiver of Rights form, advised as follows. (b)(6)

She advised that she understood her Constitution Rights and waived same by signing the Waiver of Rights form in the presence of SA's Giaquinto and Heller.

She was advised by SA Giaquinto that the interview concerned material in FBI files regarding [REDACTED] which had been prepared for HSCA access and specifically reviewed by [REDACTED] at FBI Headquarters. Additionally, the interview concerned a recovered FBI file folder containing [REDACTED] material, specifically cover pages for two deleted third agency documents. Said file folder being found by a FBI employee in a public telephone booth outside the J. Edgar Hoover (JEH) Building. (b)(7)(c) (b)(6)

She indicated that she was familiar with the material in question and had reviewed the material at FBI Headquarters on 6/13, 14 and 15/78.

She identified the recovered file folder as being part of the material she signed for the above dates. However, she denied having any knowledge regarding the whereabouts of the staff copies for Sections 2 and 3. She indicated that she signed for all the material charged out to her without checking to see if in fact all the Sections were actually there.

She advised that a review of her notes indicated that on 6/13/78 she reviewed Section 1 of [REDACTED] main file, Serials 1 through 74. On 6/14/78, she reviewed Section 5, Serials 163 - end. On 6/15/78, she reviewed Section 4, Serials 137 through 162. She advised that she had not made an inquiry regarding the whereabouts of Sections 2 and 3 as she planned on returning to FBI Headquarters on 6/16/78 to complete her review. (b)(7)(c)

She advised that when she charged out the material on 6/15/78, the recovered file folder was in fact with the material; however, she does not believe that five Sections of the main file were given to her. She indicated that she again signed for the material without specifically checking for all Sections.

She advised that at approximately noon, on 6/15/78, she gathered up her work papers, newspaper and a manila legal-style folder and carried the [redacted] material to the front desk of CIU, whereupon she was checked out by SA Hatfield. She did not recall having the recovered file folder in her possession when she left the JEH Building. (b)(7)(c)

She stated that she exited JEH on the 10th Street side, crossed the street and proceeded to a fruit vendor on the corner of 10th and E Streets, Northwest. She stated that she did not notice or recall dropping anything while on 10th Street or while proceeding to the Metro stop at 11th and G Streets. She speculated that she may have accidentally gathered up the file folder with her work papers and newspaper and subsequently lost it on the street without her knowledge. Continuing interview of Ms. Orr failed to reveal any additional information regarding staff copies of Sections 2 and 3.

[redacted] consented to a search of her desk, file cabinets and work area at the House Annex Building, which was conducted with negative results. The interviewing Agents concluded their business at the HSCA and returned to FBI Headquarters. (b)(7)(c)
