

This additionally confirms that on December 4, 1978, Hiss Hess made available to Special Agent Giaquinto a copy of the attached request indicating that the project needed to be completed by December 8, 1978. Hiss Hess was apprised of the fact that the request represented a complex research project; however, the FBI would make every effort to provide the HSCA with all retrievable information regarding the 117-maned individuals. In conclusion, Hiss Hess indicated that the HSCA was not desirous of being provided access to the material in view of the short deadline involved, and that this written response would satisfy the HSCA needs at this time.
