Reference is made to letter to the Attorney General from G. Robert Blakey, Chief Counsel and Director, HSCA, undated, requesting specific information about 117 individuals described as being pertinent to the John F. Kennedy assassination investigation.

This confirms a conversation of December 4, 1978, between Miss Jacqueline Hess, HSCA, and Special Agent John S. Giaquinto, FBI Headquarters (FBIHQ), wherein Miss Hess, upon her inquiry as to the status of the attached copy of the Committee request, was advised of the fact that said request had never been received at FBIHQ.

This additionally confirms that on December 4, 1978, Miss Hess made available to Special Agent Giaquinto a copy of the attached request indicating that the project needed to be completed by December 8, 1978. Miss Hess was apprised of the fact that the request represented a complex research project; however, the FBI would make every effort to provide the HSCA with all retrievable information regarding the 117-named individuals. In conclusion, Miss Hess indicated that the HSCA was not desirous of being provided access to the material in view of the short deadline involved, and that this written response would satisfy the HSCA needs at this time.

DETAILS: On 12/5/78, SA William Albrecht, Jr., conducted an examination on a weapon which was identified as being the rifle used by Oswald to assassinate Kennedy. The examination was done in the presence of Ken Kline and Surrel Brady of the House Select Committee and Michael Leahy of the Archives. The purpose of the examination was to locate a particular area on the underside of the barrel where Oswald's print was lifted, based upon a series of imperfections which showed up in the lift. This particular area was found and pointed out to the members of the Select Committee. The outer limits of the area were also marked with evidence tape, the forward most piece of tape being 10 1/4 inches from the muzzle.
