SAID SHE AND WIFE CONVINCED ON EASIS THEIR INTIMATE KNOWLEDGE OF NOSENKO (MARRIAGE HAS LASTED 11 YEARS) THAT HE WOULD NOT LEAVE THEM AND HIS TWO CHILDREN VOLUNTARILY, AND THAT "THIS" WAS "PROVOCATION" BY US SIDE.

MOTHER SAID SHE UNDERSTOOD DECISION ON MEETING COULD NOT BE MADE IMMEDIATELY, BUT MATTER IS IMPORTANT AND URGENT. SAID SHE WOULD CALL DOISUL IN 2 - 3 DAYS TO ASCERTAIN IF ANSWED HEADY.

VOEN LEFT THREE SEALED LETTERS FOR NOSENKO, ONE FROM EACH OF THEM AND ONE FROM HIS DAUGHTER, WITH REQUEST THEY BE DELIVERED. LETTERS WILL BE POUCHED MARCH 3.

CONSUL SAID HE WOULD REPORT THEIR REQUEST. UPON HIS REQUEST FOR EVIDENCE OF I DENTITY, MOTHER PRODUCED WORN I DENTITY CARD WITH MICTURE, IN NAME TAKARA IGNATYOVNA NO ENKO. WIFE SAID SHE HAD NO I DENTIFICATION WITH HER.

EMBASSY WILL VOLUNTEER NO INFORMATION TO PRESS. IF STORY OF WISIT LEANED BY SOVIETS, EMBASSY SUGGESTS IT LIMIT ITS RESPONSE TO PRESS QUERIES TO SAYING THAT HE HER AND WIFE OF MOSENKO CAME TO EMBASSY AND SAW CONSULAR OFFICE. NO RPT NO COMMENT WOULD BE MADE

WIFE AND MOTHER SOCIET DEFECTOR NOSENKO CAME TO EMBASSY TODAY AND ASKED TO CHE AMMASSADOR. HERE REFERRED TO CONSULAR OFFICER. TOLD CONSULAR OFFICER THEY WOULD, SPEAK ONLY WITH AMBASSADOR AND DEMANDED AMBASSADOR PECFIVE THEM OR EXPLAIN WHY HE WOULD NOT DO SEL PRUTARED WAIT ALL DAY IF NECESSARY.

WERE TOLD AMBASSADOR OCCUPIED AND THAT CONSULAR OFFICER COULD GIVE THEM NO MOPE AMBASSADOR COULD SEE THEM LAT ANY FUTURE TIME. AMBASSADOR HAD AUT.ORIZED CONSULAR OFFICER HEAR WHAT THEY HAD TO SAY AND TRANSMIT IT TO HIM.

THEY SAID IT "IMPOSSIBLE" THAT AMBASSADOR REFUSED RECEIVE MOTHER AND WIFE MOSENHOU REFUSED DISCUSS THEIR BUSINESS WITH CONSULAR OFFICER. SAID IT WOULD ONLY TAKE FIVE MINUTES OF AMBASSADOR'S TIME. IN REMARKS TO EACH OTHER AS THEY LEFT, THEY SAID THEY WOULD RETURN AGAIN AND/OR WAIT ON STREET UNTIL AMBASSADOR CAME OUT OF ENDASSY (NO VISIBLE SIGN THEY HAVE.

BOTH WOMEN WHILE-PRESSED I BLACK, AS YF IN MOURNING, CLOTHES APPEARED REASONABLY STYL H, WELL-MADE, MEW. TWO WOMEN APPEARED UNDER STRAIN BUT DID NOT BREAK DOWN, SHOUT, CHY, ETC. ACTED IN HAUGHTY AND DUNASDING MANNER.

MOTHER, TAIL TOWN IN HE SITTIES, TOOK LEAD IN CONVERSATION, MAKING HET POINTS ENGLAT DALLY BUT WITH ONLY SLIGHT TRACES ENTERED DISCUSCION ONLY IN TAIL INTERVALS. LOTH APPEARED URBAN AND EDUCATED.


