

On Transmitted her lith is a copy of a repo a copy of a report on the SAMMY case prepared by the Chief, Soviet Russia Division for the information of the Deputy Director for Plans. It is an "in house" document containing an interim assessment of SAMMY's bona fides and may not be disseminated to other departments without permission of this Agency. The resert is loaned to your Bureau per paragraph 5 of referent manorandum.

After reviewing the origins of the SAMMY case, the report discusses SABMY's motivation, his production to date, his behavior, and certain other cases which appear to relate in some way to the SAMMY case. The report concludes that SAMMY is a RGB plant, discusses possible KGB aims in such an operation, and recommends action to resolve the case.

In previous corraspondence, this Agency has noted the need for an early evaluation by our Bureau of the information reported by SAMIY on American citizens. This evaluation not only will affect the manner inclinich portions of this information pertaining to other agencies and Capartments would be disseminated but also will form an important part of the final determination of SAMMY's bona fides. 4. In considering how best your Bureau and this Agency can proceed in further examination of this case, it is probable that normal procedures, for exchange of information will not suffice. SAMMY is a unique case for which no parallel exists insofar as we are aware and proper resolution suggests the need for the

cooperation on the part of those specialists in your Bureau and this Agency concerned with operations against the Soviet intelligence services. Specifically, it is requested that after your Bureau has examined this report, representatives of your Bureau and this Agency meet to review all aspects of the SAMMY case. This review should take place before the confrontation with SAMMY, recommended in the report, takes place. We are presently planning this for sometime in April.


