On 19 August 1964 while reviewing lists of Soviets who came to the United States in the Summer of 1959 in connection with the Soviet Trade Exhibit in New York City, SAMMY identified Ivap the States Kong LENKO as a KGB officer who was at that time (1959) assigned to the First Section (American Embassy), First Department (United States), Second Chief Directorate (Internal Counterintelligence). I: SAMMY MATION UNCLAS further stated that he knew that KURILENKO had travelled to the United States on a TDY basis a few years ago and that he did not have an assignment from his own unit but "was fulfilling a request" of the KGB residentura in the <u>с</u>ъ United States, i.e., a First Chief Directorate task ( However, he had no details on this task. SAMMY assumes that the 1959 trip and the one he described above are identical since, to his knowledge, CURILENKO, made only one trip to the United States. ( 2. Our records reflect that the only trip-KURNIENKO made to the United States was from 3 June to 23 August 1959 in connection with the above mentioned trade exhibit. 3.
