Informant remarked that at the present time no one in KGB quarters, to his knowledge, is talking about YURI NOSENKO. Informant said that in the recent past he has chatted with many of the KGB employees of the NY Residency concerning NOSENKO, but said that no one appears to know where NOSENKO is at the present time or what he is doing. The general consensus of opinion among KGB employees in NY is that in the future KGB will be feeling sharply the effects of NOSENKO's "escape" to American intelligence authorities.

Informant said that based on these general conversations with other KGB personnel, he has gotten the impression that NOSENKO is considered to be vastly more important than either ANATOLI GOLITZYN or PETR DERJABIN, to Soviet nationals who have also defected to American intelligence authorities in the past.

Informant said that this opinion appears to be based on several factors, each of which has a great deal of validity. Informant remarked that NOSENKO, first of all, worked against personnel stationed at the American Embassy in Moscow, and stated that with NOSENKO's help agents were developed among these Americans working in the enbassy. Secondly, informant said that it is assumed by KG3 personnel that because of this closeness to the American Embassy in the past, NOSENKO would also be familiar with the number of microphones which had been installed in the American Embassy by KGB and the locations of these microphones.
