He said, however, that after becoming well acquainted with her, she would frequently advance the Soviet "line" and then, with a smile, acknowledge the truth as it differed from what she had just said. This source said that on occasions while in Moscow, he was aware of being followed. No attempt, however, was made to harass him or involve him in a compromising or embarrassing situation. He said that to his knowledge, he was not in contact with anyone affiliated with Soviet Intelligence. (S)(u)

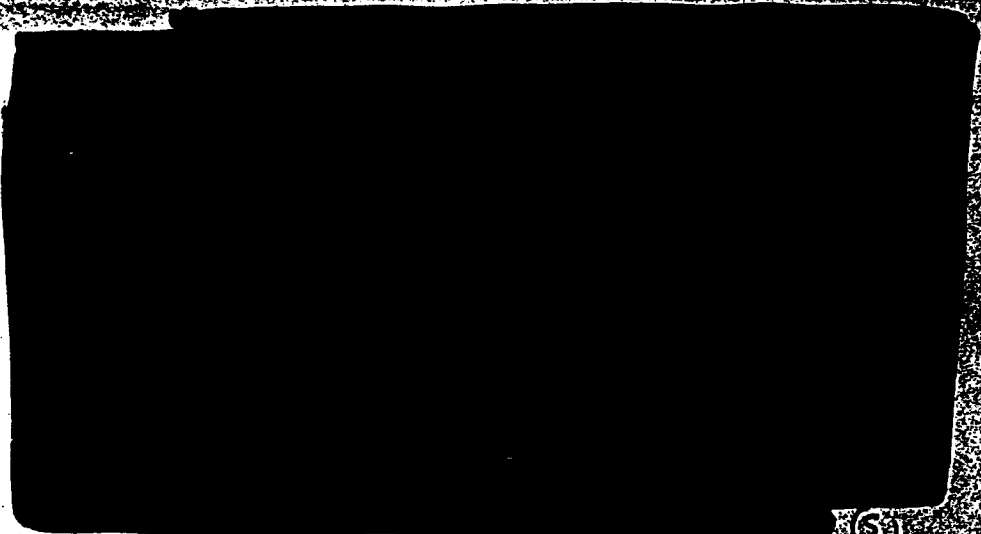
