the "Los Angeles Times" newspaper, July 23, 1964 issue, carried an article, captioned "Russ Accuse Tourists of Bible Sauggling Try" and indicating origin of article as "Mescow (AP)", without date, as follows:

"A Soviet newspaper has accused foreign tourists, including two Americans, of trying to smuggle Bibles and other religious literature into the Soviet Union.

"One tourist of unidentified nationality mixed 307 ICONS and 155 religious medallions with pornographic material, the report said.

"The Communist government here publishes atheistic literature and seeks to eliminate religion, although the Russian Orthodox Church claims that elmost a quarter of the Soviet Union's 226 million people are believers.

"The report appeared in last Sunday's issue of "Soviet Byelorussia," a newspaper published in Minsk, 420 miles west of Moscow. The newspaper reached Moscow Wednesday.

The report denounced Johovah's Witnesses, accusing them of trying to work in Communist countries 'against the idea of peaceful coexistence and peace in the world'.
