Nosenko is a Soviet intelligence officer who defected on February 4, 1964, and is under the custody and control of the Central Intelligence Agency (CIA). [CIA (U)] has assigned to him the code name "Sammy." [CIA] is now furnishing copies of transcripts of further interviews of Nosenko under a new code name "Norman." [U] These transcripts are being handled on a strict need-to-know basis both at CIA and the Bureau. [U] *Information is classified per CIA policy dated 4/15/85.*

The transcripts received to date are being forwarded to the Records Branch separately for appropriate indexing and filing in captioned case and future transcripts will be handled in the same manner. This has been coordinated with representatives of the Records Branch (U)
