1. There were no formal interviews with Subject from 16 December 1967 until early 1968. This lapse of interviews has no significance since the undersigned was on vacation for a period of time over the holidays.

2. The undersigned was in contact with the Source on 18, 19, 20 and 21 December 1967, but no formal interviews were conducted due to matters which have no significance in this case.
