Nosenko is a Soviet intelligence officer who defected and is now under the custody and control of the Central Intelligence Agency (CIA). CIA initially assigned to him the code name "Sammy." It is now furnishing copies of transcripts of further interviews of Nosenko under the code name [REDACTED]
