Nosenko is a Soviet intelligence officer who defected and is now under the custody and control of the Central Intelligence Agency (CIA). CIA initially assigned to him the code name "Sammy." It is now furnishing copies of transcripts of further interviews of Nosenko under the code name [REDACTED]

By memorandum 5/22/68 arrangements were made for the Records Branch to index the transcripts received up to that date. This has been completed and transcripts of subsequent interviews can now be furnished to that Branch for indexing. This has been coordinated with representatives of the Records Branch.

1. During contact with Source on 19 July 1968, there was not a formal interview and there will not be a transcript.

2. Source, [redacted] was queried concerning Yuriy GUK who Source [redacted] opinion was a good KGB officer except for his weakness for [redacted] according to Source GUK was respected by other officers and liked by a number of officers.

3. According to Source, [redacted] and was quite firm, but would "cover up" for other officers [redacted] warning the officers about their peccadilloes. Source indicated [redacted] speaks confidentially on a number of occasions with the Source, [redacted] almost always preface his remarks by, "This is between us [redacted]"

4. According to Source, GUK indicated that he had enjoyed his tour in the United States and had made certain favorable comments in regard to life in the United States. Source indicated that GUK did not mention that GUK had ever thought seriously of staying in the United States or that he was dissatisfied with his life in the KGB.

5. Source was queried concerning whether GUK had ever mentioned any intelligence activities in the United States and stated that he could not recall that GUK had made any specific references to any agents. Source did recall that GUK, without identifying the specific agents or recipients, [redacted] talked about his participation in transmitting money to the Communist Party in the United States. Source stated that GUK, during conversation, made general references to his having transmitted money to an unnamed individual or individuals, this money being furnished by the Soviets to the Communist Party of the United States. Source understood that these were rather large amounts
