



Extract from The 900 Days The Siege of Leningrad by Harrison E. Salisbury

Chapter 3:

"Twenty-five years after the Saturday of June 21, 1941, Admiral Kuznetsov was still trying to reconstruct what was happening behind the scenes in the Kremlin, in the Defense Commissariat, in the highest circles of the Soviet Government.

"He recalled the day as an unusually quiet one. Oridinarily his telephone was busy with calls from commissars and high officials, especially from those whom he liked to call the 'fidgety ones,' Vyacheslav A. Malyshev and Ivan I. Nosenko, the chiefs of the defense industries. The calls would come in a steady stream until about 6 P.M., when the top officials usually went home for dinner and a little rest before returning to their offices. They were in the habit of staying on duty until 2 or 3 A.M. in the event of a call from Stalin, who worked through most of the night. A commissar who was not at his desk when a call from the khozyain, or boss, came through was not likely to be a commissar the following morning."
