Top Aides Are Said to Get Orders to Work Seriously for Negotiated Accords

MOSCOW, May 4-Top Soviet officials have told American diplomats here that they have been ordered to try seriously to Megatiate agreements with the United States, reliable sources said today.

The Russian officials have said in recent days that they were told to pay closest attention to the conciliatory remarks about the United States made by Leonid I. Brezhnev, the party leader, at the recent 24th Congress of the Soviet Communist party.

Although attacking American' policy in Indochina and the Jiddle East, Mr. Brezhnev raid: "We proceed from the assumption that it is possible to ruprove relations between the J.S.S.R. and the "U.S.A."

Forcign Minister Andrei A. romyko, who is given direct sponsibility for carrying out e Kremlin directive, met with cob D. Beam, last Friday in unpublicized, wide-ranging seting, the first between the 'o men since the party coness. Mr. Gromyko and Mr. Brezhnev both accused Mr. Nixon of following "zig-zag" policies that made it hard to reach agreements.

Diplomats here noted that despite the improved atmosphere there had not been any substantive change in any of the key issues such as the Middle Eastern situation, the talks on limiting strategic arms or on Berlin, that would indicate that relations in fact would turn toward the better. Some diplomats interpreted the Soviet policy as part of a campaign to shift blame for lack of progress in any important issues to the United States.

Others said the Soviet line seemed to indicate a desire to engage in a dialogue with Washington, thereby facilitating similar Soviet contacts with Western European countries that were wary of rather obvious Kremlin efforts in recent years-to-split the United States from its partners in the North Atlantic Treaty Organization.

U. S. Domestic Problems Cited

Mr. Arbatov's article, which was read with considerable interest here, seemed an effort at justifying to hard-line Soviet and foreign Communists the continuing Soviet efforts at negotiations with the United States and other capitalist countries.

He said that the United States, wracked by domestic and foreign policy crises, was seeking a way out of its problems, and he said it was possible that it would make "realistic correctives" in its policy toward the Soviet Union.

He commented that any "concessions" made by the United States would not change the nature of the imperialist power, but said that it was wrong to reject any agreements simply because a country was imperialist.

Mr. Arbatov said that in the nuclear age it was a matter of significance to the peoples of capitalist countries whether foreign relations were develop-, ing toward a nuclear war or toward improved relations and peaceful coexistence.

"the struggle between the two systems" will continue, "but along a course in which this struggle does not lead to a military conflict."

Lenin's View Quoted

Lenin was quoted in Mr. Arbatov's article as having said that Communists must differentiate between those in the West "who lean toward a military solution of problems," and those who "lean toward paci-

Mr. Arbatov affirmed that the party congress had called for the improvement of relations with the United States.

Relations between Moscow and Washington are still somewhat strained, in part because of Soviet anger over the continued anti-Soviet demonstrations in the United States by the militant Jewish Defense League. These demonstrations led Moscow last year to cancel a planned visit to the United States of the Folshoi Ballet and Opera, and to postpone the sending of a planned Soviet folk art exhibit.

Because of the putting off of its exhibit, Moscow has barred the United States from sending an exhibit on research and development here. This in turn led to_an American protest.
