





1. Source has since October 1967 not been queried in specific detail concerning his brother but has mentioned the brother on a number of occasions starting with Operational Memorandum N-2 dated 31 October 1967. In this handwritten memorandum, Source identified his brother as NOSSNKO

"... Vladimiz/[Vladimir Ivanovich] born 1944, a student. "

2. Source has stated that the brother facially resembled the mother while the Source resembled the father. The brother, who was 17 years younger than the Source, started to attend the Institute of International Relations (IIR) in 1961. At that time was starting or had started a program of sending students abroad for nine months language practice and six years attendance was required for graduation.

3. According to Source, his brother was about 6'3", thin, and had dark hair. As of 1961, IIR students were required to take two foreign languages instead of one with the requirement that one language had to be a "more difficult" language. The brother was studying English and for the "more difficult" language was studying Arabic. Source has also stated that his brother resided with the mother, the father having died in August 1956.


