Since that time WFO has continued to send these transcripts and collateral memorandum to the NYO. The collateral memorandum contain explanations pertaining to the various interviews of SAMMY. *u*

WFO and the Bureau completely index these transcripts and, therefore, the NYO was advised that it would not be necessary for this office to also index the duplicate copies of the transcripts. In addition, WFO prepares LHMs or other suitable communications pertaining to the various subjects mentioned by SAMMY. Where main files exist, copies of these LHMs are channelized to these files. *u*

The SAMMY transcripts and collateral memos are maintained as bulky exhibits in the NYO. These transcripts take up a large volume of space. The NYO has not found it necessary during the last several years to refer to the transcripts, since pertinent information relating to individual cases is channelized by WFO as it is received. The NYO feels there is no useful purpose served in maintaining duplicate copies of these transcripts. *u*

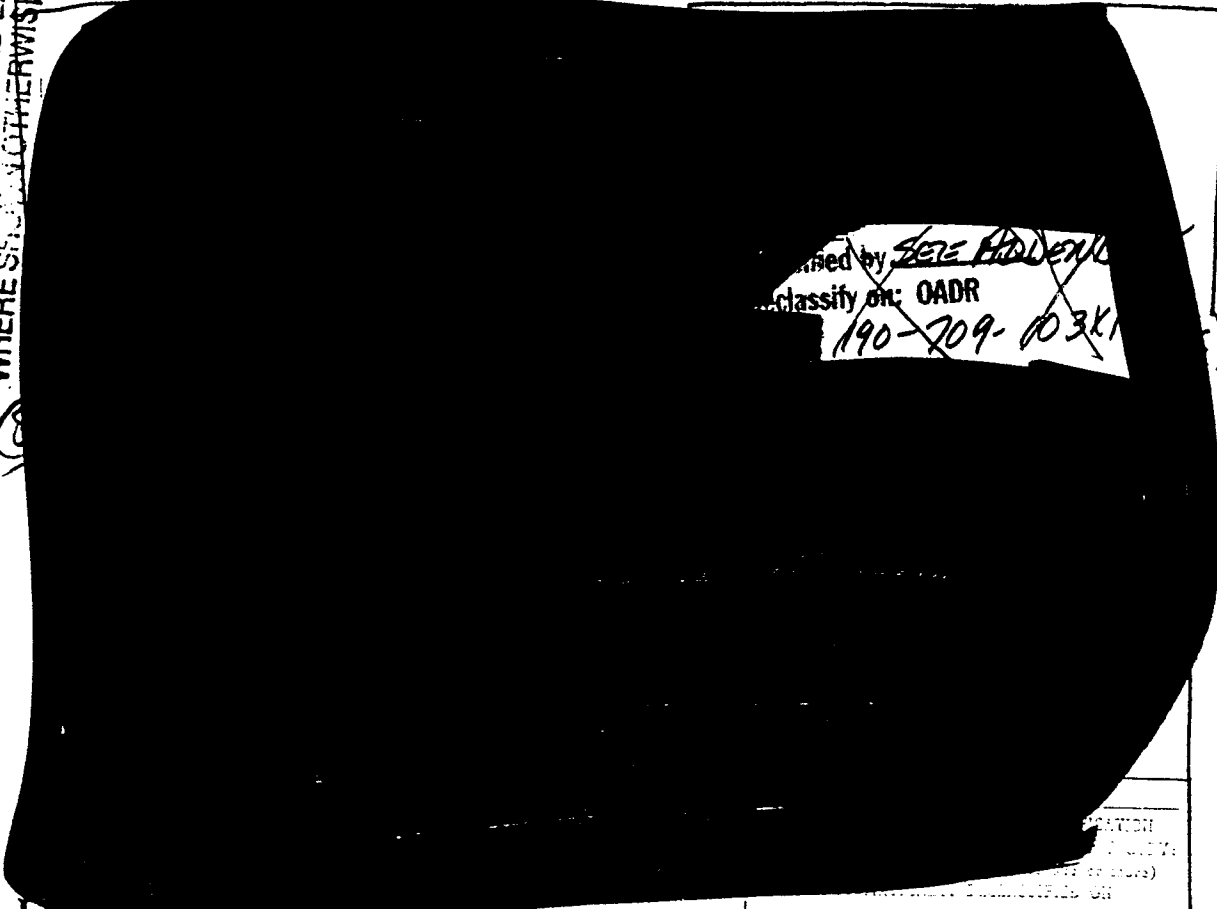

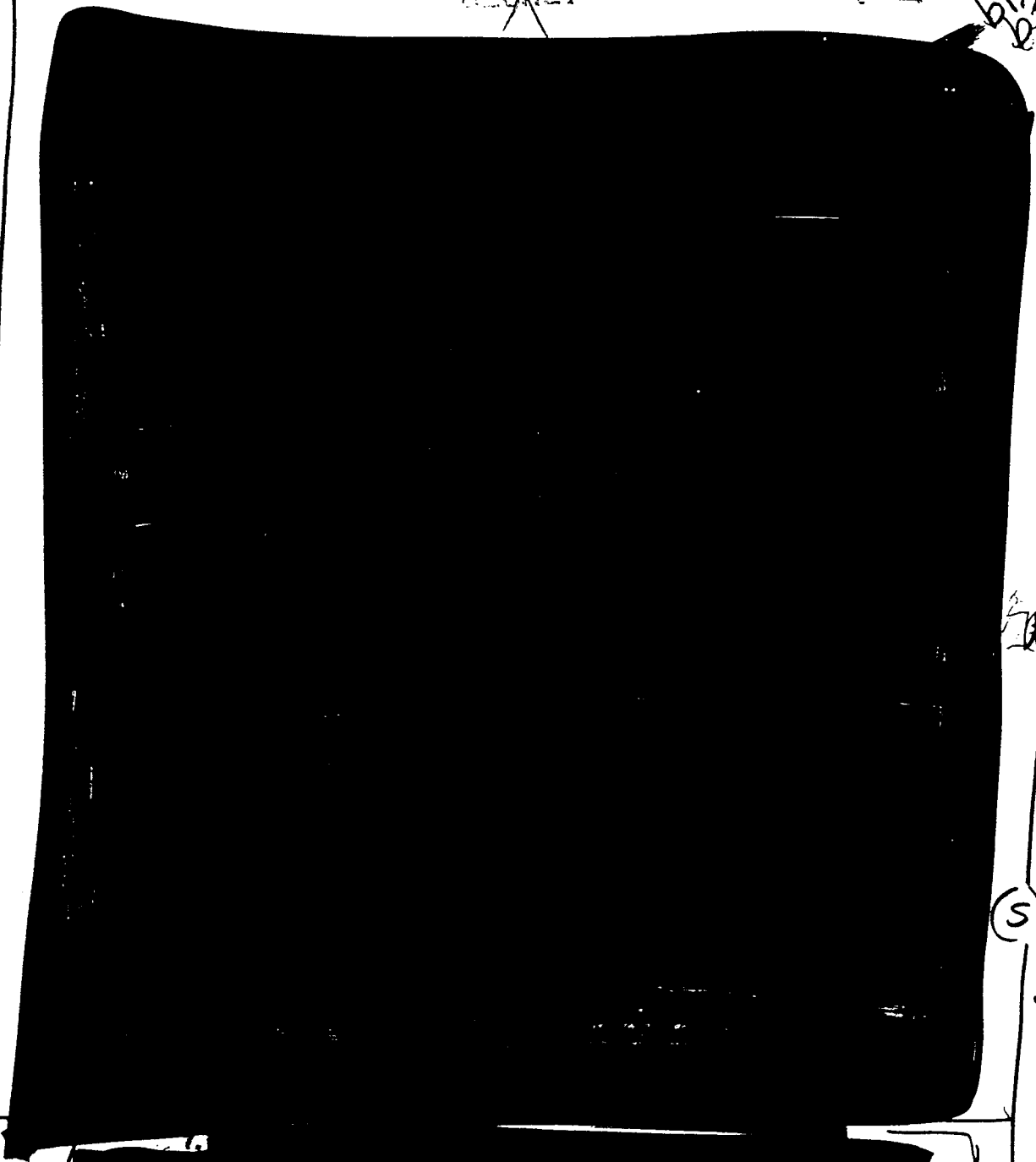

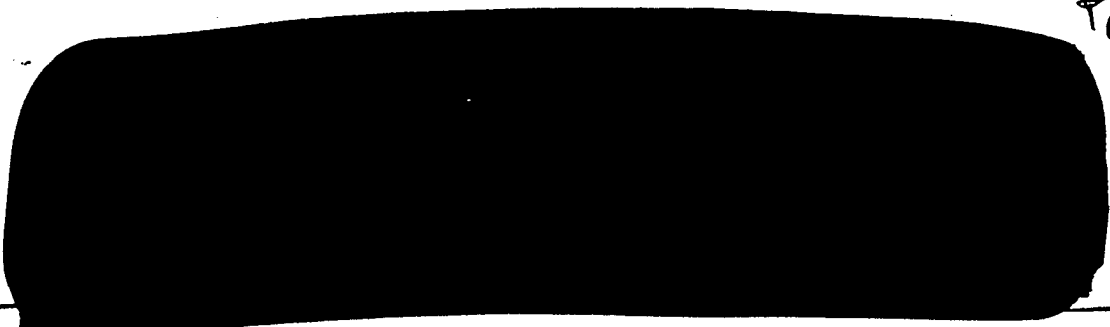

This memorandum recommends that a letter addressed to [REDACTED] by the Director expressing appreciation for the informant's appearances before our specialized training schools be given to [REDACTED]

[REDACTED] is a Soviet intelligence officer who defected in Europe to CIA in 1964. He was brought to the United States by CIA and has been resettled and supported by that agency since that time. He has furnished voluminous information to both the Bureau and CIA [REDACTED]

[REDACTED] CIA raised a question about the bona fides of this source but after extensive investigation and analysis, we concluded that without question he is a true defector. There is an element within CIA which feels the source is part of a Soviet disinformation operation. However, despite the opinion of this element, CIA has officially supported [REDACTED] since his defection and recently went on record concerning his good character during his naturalization proceedings. We feel he is a bona fide defector and will not misuse a letter from the Director. (S)(u)

[REDACTED] has appeared before several specialized training classes of the Bureau which classes have been receiving intensified training in counterintelligence work. His presentations to these classes have been well received. His most recent appearance occurred in May, 1974. (S)(u)

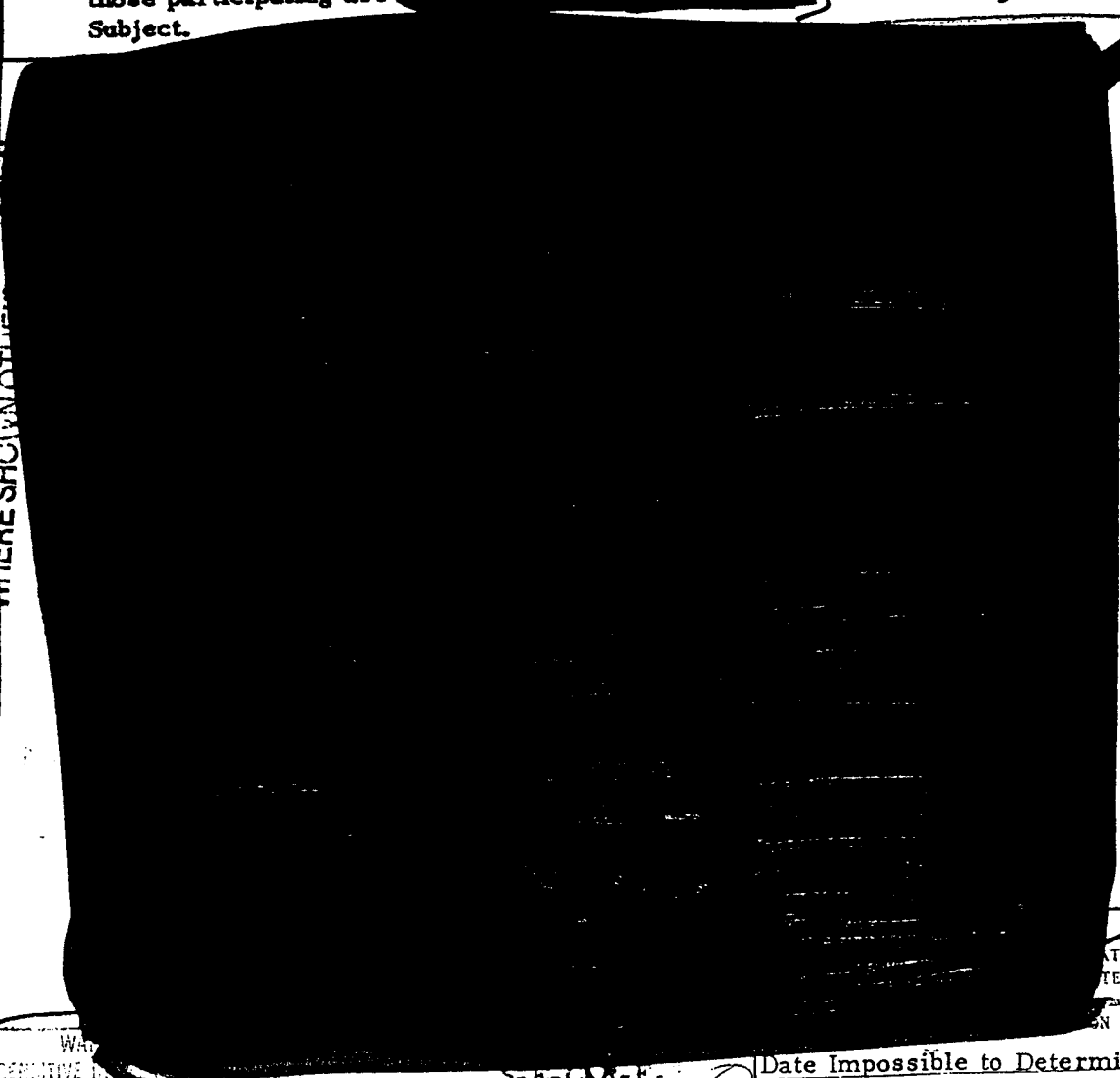

While returning from the Academy on 5/7/74, source expressed gratitude at having been permitted to lecture to this and several other FBI groups, and an appreciation for the warm receptions he received on all such occasions. He also indicated he would greatly appreciate a letter from the FBI expressing an appreciation for his cooperation in matters of interest to the Bureau. Source stated he would keep such a communication in utmost confidence, and would treasure it second only to his recently acquired U.S. citizenship (4/3/74). (S)

WFO feels a letter from the Director expressing appreciation for services rendered on behalf of the Bureau in connection with lectures and other matters would be highly desirable and justified. Source has furnished very valuable information to the FBI since early 1964 which has led to successful prosecutions in the counterintelligence field and to the identification of [REDACTED] KGB and GRU officers and agents. In addition his numerous lectures to FBI groups have been highly instructive and inspirational. It is recommended that a letter of appreciation be presented to source at his next lecture to a Counterintelligence Class, either before the class or in private by an appropriate Bureau official. 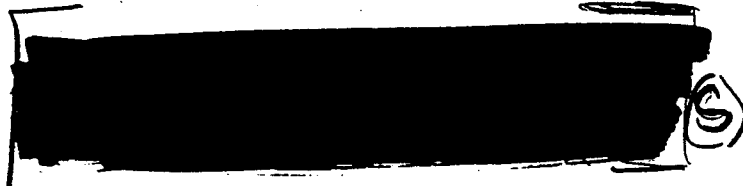

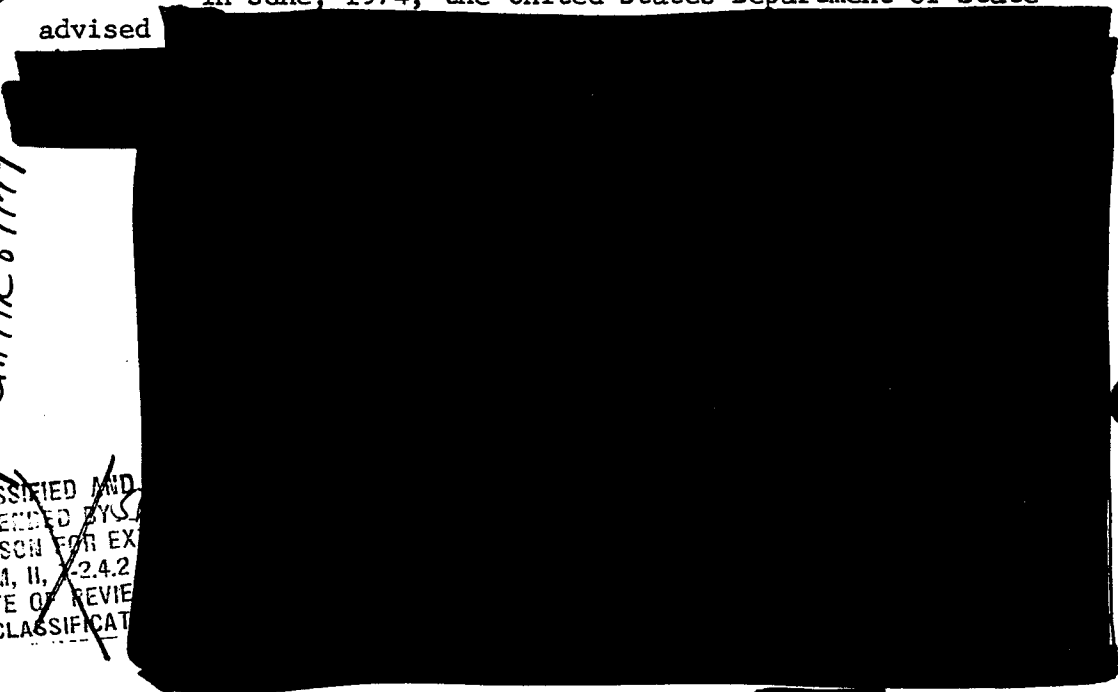
