There has been newspaper and television publicity recently indicating Soviet defector YURIY NOSENKO furnished information that LEE HARVEY OSWALD was a counterintelligence problem to KGB but was not recruited by KGB while in the USSR, thus tending to suggest there was no KGB involvement in the assassination of President JOHN F. KENNEDY. (S) (u)

It is suggested the Bureau contact [redacted] to ascertain if there was any KGB official or unofficial reaction to this recent publicity. It is suggested [redacted] also be questioned about current KGB plans to locate KGB defectors, such as NOSENKO, ANATOLIY M. GOLITZYN, [redacted] and, if located, what current plans KGB has concerning action to be taken concerning these defectors. (S) (u)

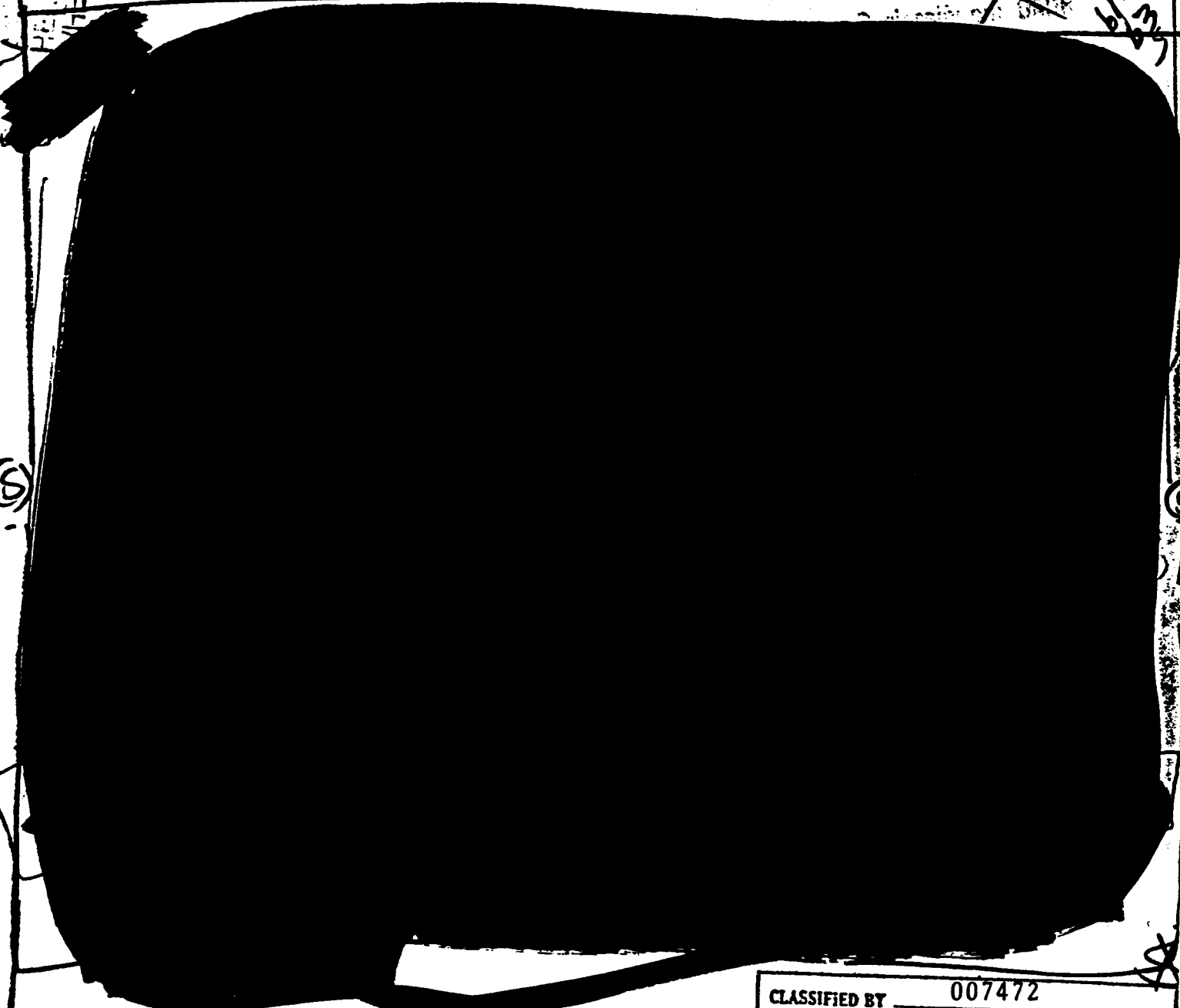
