During contact on 10/21/75, Mr. [redacted] Office of Security, CIA, stated he learned today that Mr. JAMES ANGLETON, former CIA official, contacted an official of the CIA and indicated he felt compelled to bring the question of the bona fides of subject to the United States Senate. This is causing great concern within CIA since it is felt it could have adverse repercussions not only within CIA, but in other U.S. and foreign intelligence and counter-intelligence services. (S)(u)

Possibly related to this is an article appearing in the October 10, 1975 issue of "The New York Times," which indicates one former high-ranking American intelligence official and a second former official took exception to a statement by former CIA Director John A. McCone during a May, 1975 CBS news interview that the bona fides of source has been established. Speculation within the Office of Security, CIA was that the former high-ranking American intelligence official might be JAMES ANGLETON, and the second former official might be one of the two subordinates of ANGELETON who went on forced retirement with him recently. Since the article dealt primarily with the Warren Commission and LEE HARVEY OSWALD, it appears likely the FBI could be deeply involved in any Congressional inquiry initiated by ANGLETON concerning source. 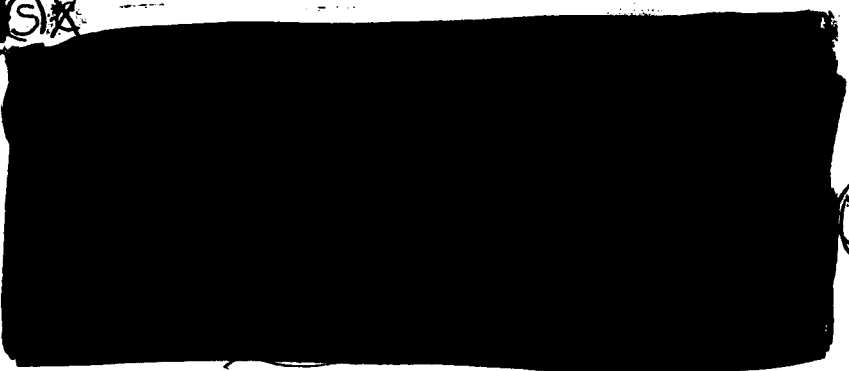
