## AF Efforts Help Cancel IBM-USSR Computer Deal

International Business Machines disclosed recently in a surprise announcement that the Corporation's application to supply a computerized reservations system, valued at more than \$11 million, to the Soviet travel agency, Intourist, has been rejected by the Commerce department.

Young Americans for Freedom, the national conservative student organization, has been waging a campaign to inform the American public of the potential danger the proposed computer facility would pose to Soviet citizens.

Intourist, the Soviet travel agency, has a reputation of being a KGB front organization. The conservative student organization, in voicing its opposition to the proposed sale, feared the computers would be used by the KGB to spy on Soviet citizens and Americans visiting the USSR.

A spokesman for IBM told HUMAN EVENTS that the proposed computer facility was a System/370 Model 158 which is a more advanced system than any in the USSR. The 370 is IBM's latest and would have been one of the largest ever purchased by the Soviet Union. "Here is where the danger lies," he added. The larger the system the more easily it is diverted to other uses. According to the spokesman, the NATO allies expressed concern and interest over the size of the facility. Incidentally, IBM has already

shipped a similar model to the Kama River foundry in the USSR.

The facility, once reprogrammed, would have the capacity to do most anything with its large data banks. "You would have to let your imagination run wild," the spokesman said. Due to the high-grade quality of the system, Soviet authorities could employ the facility to store information not only on tourists but on the movements of their own citizens. The system could also be diverted to military purposes. The corporation spokesman said "the movement of troops and supplies through the aid of a computer isn't different than moving tourists in and out of a country."

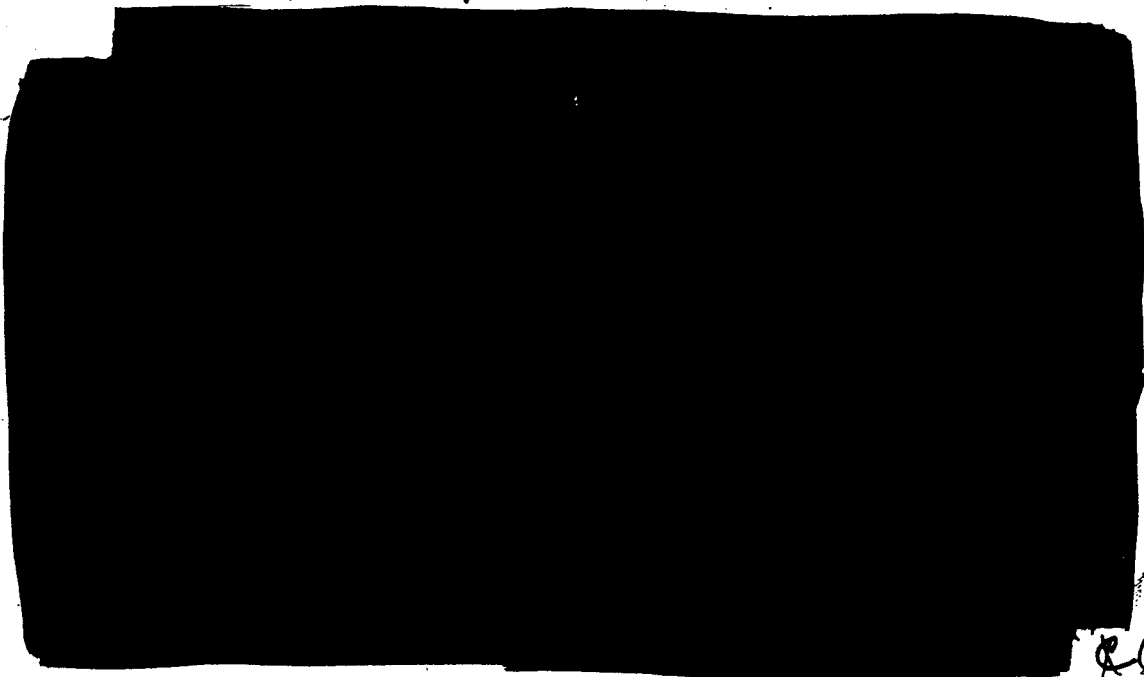

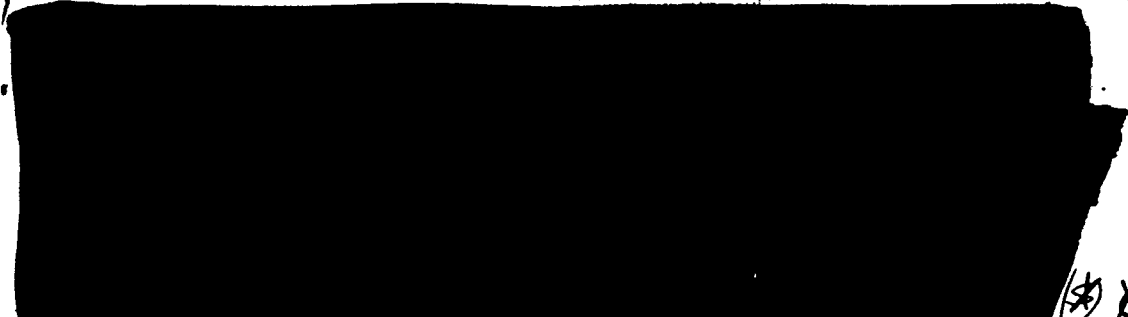
