



Memorandum to Mr. W. O. Cregar

DETAILS:

Yuri Nosenko was a KGB officer at KGB Headquarters in Moscow until his open defection to CIA in February, 1964, while on temporary duty in Switzerland. Nosenko was resettled in the United States and has been used by both CIA and us in (S)He has also

furnished information concerning

Nosenko regularly lectures before our Basic Counterintelligence Schools and our overall evaluation is that he has been of value to the FBI and that his bona fides are genuine. For some time after his defection Nosenko was considered by an element in CIA to be a Soviet plant. Further analysis by CIA and a change in personnel at that Agency resulted in the declaration that he was a genuine defector.

Recently Nosenko has been mentioned in a book entitled "Legend: The Secret World of Lee Harvey Oswald" which was condensed in two "Reader's Digest" articles. Nosenko is portrayed in the book as having defected on the orders of the KGB to support the official Soviet position that the Soviets had no part in the assassination of President Kennedy. The book has caused considerable press speculation, most of which has been anti-Nosenko. Nosenko has expressed concern that without public statements by the CIA and FBI as to his bona fides that the book will be accepted at face value. WFO, which handles our contacts with Nosenko, has been informed that FBI policy dictates against public statements attesting to the reliability or loyalty of individuals and no change in this policy is planned with regard to Nosenko. WFO was advised that a ranking official of the Intelligence Division (INTD) is available to meet Nosenko to discuss his concerns.

WFO has advised that Nosenko met with CIA Director Admiral Stansfield Turner on 4/5/78 for approximately 30 minutes and that Nosenko was appreciative of the meeting and the ensuing discussion. Admiral Turner assured Nosenko of CIA's belief in his bona fides and that he was considered trustworthy.

In view of Admiral Turner's meeting with Nosenko, the Director may desire to meet Nosenko rather than the originally planned meeting with a INTD official. In either event, INTD recommends that SA WFO, accompany Nosenko as the latter is sensitive to protocol and presence will be of benefit to us in his future contacts with Nosenko.







The author states that Oswald offered to supply military secrets of "special interest he had acquired during his service as a radar operator in the US Marines . . . " when he defected to the Soviet This is a false statement. Oswald did not make such an offer.

And further the author states: "Less than eight weeks before the assassination Oswald had met with a Soviet intelligence officer in Mexico City." The fact is that Oswald, when he arrived in Mexico City in 1963 visited the Soviet Consulate to request a visa to come to the Soviet Union. As a usual procedure the KGB has, at least one of its officers working under cover in every Soviet Consulate around the world. These KGB officers screen foreigners who visit Soviet Consulates.

The author says: ". . . I thus began my research for this book by interviewing a Soviet intelligence officer who had defected to the United States ten weeks after the assassination and claimed to have superintended the KGB case file on Oswald."

A senior editor of the Washington Bureau of Reader's Digest, Mr. John Barron, who has been my friend since 1970, told me that Reader's Digest invited a writer, Edward Jay Epstein, to write a book on the assassination of President Kennedy and asked if I could meet Mr. Epstein and tell him what I knew about Oswald. I agreed to meet Mr. Epstein and an editor of Reader's Digest, Mr. Fulton Oursler who was at the head of this Reader's Digest project. I met them only onco. The meeting took place in the Washington Bureau of Reader's Digest in the room of Mr. John Barron, who was not present at the interview. The interview lasted between 3-4 hours. I agreed to the use of a tape recorder, but the conversation was only partiall taped because Mr. Oursler did not know how to use the tape recorder properly. In the beginning I stated that I was a former Soviet
