Yuri Nosenko was a KGB officer at KGB Headquarters in Moscow until his open defection to CIA in February, 1964, while on temporary duty in Switzerland. Nosenko was resettled in the United States and has been used by both CIA and us in [REDACTED] (S) He has also furnished information concerning [REDACTED]

[REDACTED] Nosenko regularly lectures before our Basic Counterintelligence Schools and our overall evaluation is that he has been of value to the FBI and that his bona fides are genuine. For some time after his defection Nosenko was considered by an element in CIA to be a Soviet plant. Further analysis by CIA and a change in personnel at that Agency resulted in the declaration that he was a genuine defector. (S)(u)

Recently Nosenko has been mentioned in a book entitled "Legend: The Secret World of Lee Harvey Oswald" which was condensed in two "Reader's Digest" articles. Nosenko is portrayed in the book as having defected on the orders of the KGB to support the official Soviet position that the Soviets had no part in the assassination of President Kennedy. The book has caused considerable press speculation, most of which has been anti-Nosenko. Nosenko has expressed concern that without public statements by the CIA and FBI as to his bona fides that the book will be accepted at face value. Nosenko has also indicated concern for his and his family's safety since the book [REDACTED] (S)

WFO, which handles our contacts with Nosenko, has been informed that FBI policy dictates against public statements attesting to the reliability or loyalty of individuals and no change in this policy is planned with regard to Nosenko. WFO was advised that a ranking official of the Intelligence Division (INTD) is available to meet Nosenko to discuss his concerns. (S)(u)

WFO has advised that Nosenko met with CIA Director Admiral Stansfield Turner on 4/5/78 for approximately 30 minutes and that Nosenko was appreciative of the meeting and the ensuing discussion. Admiral Turner assured Nosenko of CIA's belief in his bona fides and that he was considered trustworthy. (S)(u)

In view of Admiral Turner's meeting with Nosenko, the Director may desire to meet Nosenko rather than the originally planned meeting with a INTD official. In either event, INTD recommends that SA [REDACTED] WFO, accompany Nosenko as the latter is sensitive to protocol and SA [REDACTED] presence will be of benefit to us in his future contacts with Nosenko. 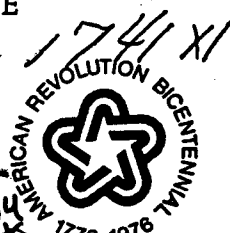

On 4/27/78, SA [redacted] CI-1 Section, INTD, contacted Mr. Keuch and explained the nature of the information requested by the HSCA and the proposed FBI excision. The Staff was advised of both FBI and CIA concern over the leaks of classified information in the magazine articles. The [redacted] case and its bearing on the question of the bona fides of Nosenko were discussed, the Staff was advised that with regard to Nosenko the FBI had no reason to doubt his bona fides and that we concur with current CIA judgment in that respect. With regard to [redacted] the Staff was advised that in the FBI's best operational judgment [redacted] was not bona fide but rather a controlled KGB asset. It was explained to the Staff that this was not a judgment in which CIA concurred but that the difference in our judgment did not prevent us from working closely together on the case and indeed our working relationship with CIA was an extremely good one. In response to a series of questions from Mr. Latimer, SA [redacted] briefly outlined the basis for the FBI's judgment with regard to [redacted] and considerable discussion then followed as to the differences in CIA-FBI evaluation of any given piece of information. Mr. Latimer asked CIA if their judgment would change and they would accept the FBI judgment if despite the news articles [redacted] were still alive and apparently undamaged. While CIA acknowledged that this would be an additional factor to consider they would not concede that such an event would be conclusive. (S)(u)

In order to complete the exhaustive search for this missing file, each division is requested to have its own personnel search all space within its control in an effort to find the file.

Likewise, it is believed necessary for the RMD to conduct a complete cabinet check of the over 7,000 file cabinets in RMD space. In order to do this complete check, it will be necessary for about 150 employees to work on Saturday, 5/20/78. This would involve a complete search through each drawer of the file cabinets and would also serve to locate any other possible misfiled files. (It is noted that logical cabinets, such as those in the 65 classification, have already been searched.)

Mr. Blakey objected strongly to being the only Staff member permitted to review the FBI files on [redacted] and stated that actually seven members of the Staff should be granted access to the material. FBI representatives again pointed out their concern that sensitive sources not be compromised and that we were dealing with human lives which we should make every effort to protect. Congressman Devine stated that since the review in the [redacted] file was limited to only that information which he had provided on Nosenko (roughly 25 pages) that it was his belief that Mr. Blakey could accomplish the review by himself and that the Committee should take cognizance of the FBI's concern for sources. The study was done by a retired former senior officer of the Directorate of Operations, Mr. John L. Hart. This study constitutes the basis for CIA's official position concerning Nosenko's bona fides.

2. The study is especially important in helping the reader understand the methodology originally used to demonstrate that Nosenko was not bona fide and the pitfalls inherent in such a rigid methodology.

The author states that Oswald offered to supply military secrets of "special interest he had acquired during his service as a radar operator in the US Marines . . ." when he defected to the Soviet Union. This is a false statement. Oswald did not make such an offer.

And further the author states: "Less than eight weeks before the assassination Oswald had met with a Soviet intelligence officer in Mexico City." The fact is that Oswald, when he arrived in Mexico City in 1963 visited the Soviet Consulate to request a visa to come to the Soviet Union. As a usual procedure the KGB has, at least one of its officers working under cover in every Soviet Consulate around the world. These KGB officers screen foreigners who visit Soviet Consulates.

The author says: ". . . I thus began my research for this book by interviewing a Soviet intelligence officer who had defected to the United States ten weeks after the assassination and claimed to have superintended the KGB case file on Oswald."

A senior editor of the Washington Bureau of Reader's Digest, Mr. John Barron, who has been my friend since 1970, told me that Reader's Digest invited a writer, Edward Jay Epstein, to write a book on the assassination of President Kennedy and asked if I could meet Mr. Epstein and tell him what I knew about Oswald. I agreed to meet Mr. Epstein and an editor of Reader's Digest, Mr. Fulton Oursler, who was at the head of this Reader's Digest project. I met them only once. The meeting took place in the Washington Bureau of Reader's Digest in the room of Mr. John Barron, who was not present at the interview. The interview lasted between 3-4 hours. I agreed to the use of a tape recorder, but the conversation was only partially taped because Mr. Oursler did not know how to use the tape recorder properly. In the beginning I stated that I was a former Soviet
